**Section II. Duties and Functions of the Council.** The PCAT VAWC Council shall perform the following duties and functions:

1. Institute policies and programs to protect women and children who are victims of trafficking and violence (formulate local resolutions);
2. Create and establish systems on surveillance, investigation, and rescue to ensure effective and efficient coordination;
3. Undertake information, education, and advocacy campaign against trafficking in persons and VAWC effective; and
4. Monitor and oversee the strict implementation of RA 9208, RA 9262 and other related laws for the protection of women and children, and of the IACT and ACVAWC national plans and actions.

**Section III. Secretariat.** There shall be a Provincial PCAT VAWC Secretariat duly designated by the Chairman of Council which shall provide administrative and technical support to the council.

**EXECUTIVE ORDER NO. 14**

Series of 2019

**"PROVIDING FOR THE CREATION OF THE PROVINCIAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (PCAT-VAWC), DEFINING ITS DUTIES AND FUNCTIONS."**

**WHEREAS**, RA No. 9262 declares that the State shall give highest priority to the enactment of measures and development programs that will promote human dignity, protect the people from violence and exploitation, eliminate trafficking in persons, and mitigate pressures for involuntary migration and servitude of persons to ensure their recovery, rehabilitation and integration;

**WHEREAS**, RA No. 9262 underscores the commitment of the state in safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security;

**WHEREAS**, the two laws provide stronger mandates and direction to relevant government agencies and stakeholders to immediately address human trafficking and VAWC by organizing committee on Anti-Trafficking and VAWC at the provincial level.

**NOW THEREFORE, I, EDUARDO B. GADIANO**, Governor of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the ORGANIZATION OF THE PROVINCIAL PCAT-VAWC COMMITTEE in the Province of Occidental Mindoro.

**Section I. Composition.** The Provincial Committee on Anti-Trafficking and Violence Against Women and their Children (PCAT-VAWC), shall be composed of the following:
