Section VII. TYPES OF ASSISTANCE. The following are the types of assistance that the Provincial Government may initiate and the qualified rebel returnee may access for only his/her eventual mainstreaming and enhancement:

- A. **Counseling Services** – this refers to an intervention performed by a Social Worker with the qualified client for the purpose of resolving personal, family and community related issues that could hinder the rehabilitation of the client;
- B. **Immediate Food Assistance** – this refers to foodstuffs e.g. rice, canned goods, etc. that may be provided to qualified clients who usually encounters difficulty in securing sustenance for his/her family's food requirement while they are in the period of adjustment;
- C. **Financial Assistance** - this refers to the livelihood assistance that may be provided to qualified clients as an aide and support in uplifting their socio-economic status. Financial assistance may be availed individually or by group:
  - c.1 Individual - Financial assistance will be provided to former rebels who surrendered before CY 2013 and were not able to avail the livelihood assistance from the Department of the Interior and Local Government and OPAPP. Former rebels who surrendered in CY 2013 onwards and did not qualify to the requirements of the OPAPP are also qualified to avail this assistance.
  - c.1 Group – Former rebels' organization may benefit of this assistance provided that they submit a project proposal for a feasible project.
- D. **Referral Services** – this refers to the official procedure of recommending the client to other agencies, institutions or organizations for support or further assistance/s where Provincial Government has established link.

Section VIII. Documentary Requirements for Processing of Assistance. For purposes of confidentiality, only the following documents shall be attached in the processing of financial aid to clients: (a) Profiling Tool/Intake Sheet; (b) Referral from PSWDO; (c) Social Case study Report; (d) Individual Reintegration Plan; and (e) ECLIP Committee Certification

Section IX. Monitoring and Evaluation. The ECLIP Committee shall oversee the project coordination, implementation, monitoring and evaluation. The committee shall meet quarterly or as the need arises. Periodical monitoring shall also be conducted to the livelihood projects implemented by the former rebels or groups who availed the financial assistance.

Section X. Effectivity. This Executive Order shall take effect immediately.





3.2 DUTIES AND FUNCTIONS OF THE FOCAL PERSON AND THE TWG. The ECLIP Focal Person and the TWG shall be tasked with the following:

1. Submit to the Task Force Balik Loob the ECLIP Directory;
2. Lead in the preparation and submission of the ECLIP Implementation Plan;
3. Submit to the TFBL Secretariat, through the DILG, accomplishment reports of the ECLIP Committee, which includes ECLIP Committee Activities, Issues and Concerns, and Updates on the Former Rebel Database;
4. Review and evaluate project proposals submitted to its level by the Local Government Units;
5. Facilitate approval of the PPOC endorsed projects of the LGUs;
6. Establish mechanism to ensure that proposed projects are in consonance with ECLIP program eligibility criteria as prescribed by laws;
7. Conduct site visits and field validation to further assess the feasibility of proposed projects when necessary;
8. Submit reports pertaining to the implementation of the projects to the Governor through the Provincial Administrator and subsequently submit the same to the DILG;
9. Supplement the individual reintegration plan;
10. Perform such other functions as may be directed by the ECLIP Chairperson

Section IV. MEETINGS. The members shall convene at any time or as often as necessary as determined and presided by the Chairperson or by the Vice-Chairperson, in case of absence of the Chairperson.

Section V. COVERAGE. Livelihood assistance fund shall be provided to qualified individual or group of beneficiaries who were former rebels of the communist armed rebellion movement operating within the Province of Occidental Mindoro.

Section VI. ELIGIBILITY REQUIREMENTS. The following criteria are set forth in order for a former rebel to qualify to the livelihood assistance program:

- a) Client who underwent validation and authentication of the ECLIP Committee;
- b) Client has voluntarily opted to peacefully return to the fold of law and has not been demobilized by reason of captivity by any government law enforcement units;
- c) Client has underwent thorough assessment and psychological debriefing by a registered Social Worker of the municipal LGU where the client resides;
- d) Client has openly renounced to use firearm/s and/or violence in the future as a way of expressing redress and grievances to the government;
- e) Client has planned and agreed to participate in community activities where he or she intends to reside in the next two years as part of his/her mainstreaming and of the healing of communities affected by conflicts;
- f) Those found with pending cases in court and/or currently held detained due to offenses committed while they were actively involved in the armed movement may still avail the assistances that this LGU may provide after their sentence had been served.

4. Facilitate the profiling of the FRs, through the PSWDO;
5. Assist the FR in completing the ECLIP Enrolment Form. The FR should either sign or thumb mark the Form after completing it, attested by the DILG Provincial Director and approved by the Provincial Governor or by his designated officer, preferably the Provincial Administrator;
6. Assist the FR in the preparation of his/her Former Rebel Reintegration Plan (FRRP) and Business Plan, with the PSWDO as the lead agency to assist the FR. It shall have the option to come-up with its template of the FRRP and Business Plan, as long as the minimum data sets reflected in the Sample Forms in Annexes E and F of the DILG-DND JMC 2018-01 are considered;
7. Resolve issues and concerns affecting the implementation of the ECLIP;
8. Provide updates to the PPOC during its meetings regarding the progress of the ECLIP;
9. Intensify advocacy and information dissemination to raise the level of awareness on ECLIP;
10. Strengthen the evaluation and monitoring system; and,
11. Coordinate and monitor the ECLIP implementation in the province.

**PROVIDING FOR THE AMENDMENT OF THE ENHANCED COMPREHENSIVE LOCAL INTEGRATION PROGRAM (ECLIP) COMMITTEE FOR THE PROVINCE OF OCCIDENTAL MINDORO, DEFINING ITS DUTIES AND FUNCTIONS AND APPROPRIATE FUNDS THEREFOR**

**WHEREAS**, the 1987 Philippine Constitution declares that the maintenance of peace and order, the protection of life, liberty and property and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

**WHEREAS**, Republic Act 7160, otherwise known as the Local Government Code 1991, mandates the Local Government Units (LGUs) to provide social welfare services which include programs and projects for former rebels;

**WHEREAS**, President Rodrigo Roa Duterte issued Administrative Order No. 10-2018 which aims to centralize all government efforts for the reintegration of former rebels in order to maximize their socio-economic and political impact by ensuring the effective and efficient implementation thereof. Likewise, the said AO adopts an Enhanced Comprehensive Local Integration Program, to be known as **ECLIP**;

**WHEREAS**, to give effect to AO No. 10-2018, DILG-DND Joint Memorandum Circular 2018-01 was signed that provides for the implementing guidelines for the provision of DILG administered package of assistance for former rebels (FRs) and Militia ng Bayan (MB);

**WHEREAS**, the Provincial Government of Occidental Mindoro has initiated projects and activities that resulted to the identification and organization of former rebels living within the province, thereby prompting some of those active members of the rebel movements to return to the fold of the law;

**NOW, THEREFORE**, in order to operationalize the implementation of the ECLIP as an improved reintegration program for former rebels, I, **EDUARDO B. GADIANO**, Governor of the Province of Occidental Mindoro, by virtue of the power vested in me by law, do hereby order the organization of the Enhanced Comprehensive Local Integration Program (ECLIP) Committee, defining its duties and functions and appropriating funds therefor.

SECTION I. Composition. The ECLIP Committee shall be composed of the following:
