- f. Strengthen linkages between and among government and non-government women's organizations and encourage active participation for their welfare, promotion, and development; and
- g. Undertake any other projects, activities, and functions pertinent to the promotion of women's concerns.

SECTION III. Designation of Provincial GAD Focal Person. The personnel listed below is hereby designated as the Provincial GAD Focal Person:

MR. MICHAEL D. CAPONPON – Population Program Officer II

The Provincial GAD Focal Person shall have the following functions:

- a. Sees to it that Gender and Development concerns especially women and children are reflected in the Provincial Annual GAD Plan and that implementation is made thereto; and
- b. Prepares the Provincial Annual GAD Accomplishment Report to be submitted to the DBM Regional Office, copy furnished the DILG Provincial Office.

SECTION IV. Secretariat. There shall be a Provincial GAD Secretariat duly designated by the chairman of the Council which will provide administrative and technical support in the Council.

The Secretariat of Provincial GAD Council shall be composed of the following:

The Secretariat shall have the following functions:

- a. Provides administrative support to the council;
- b. Organizes and makes all necessary arrangement for the Council meetings;
- c. Be the central channel of communication for the Council with the other line agencies, other government agencies, civil works and consulting services and the public.

SECTION V. Funding. For this purpose, 5% of the LGU's total budget appropriation is hereby appropriated for the realization and implementation of its programs and activities including seminar and workshop of GAD representation, as mandated under Section 27 of General Appropriation Act.

SECTION VI. Effectivity. This Order shall take effect immediately.

- c. Monitor and implement the plan in cooperation with the private sectors, women NGOs and POs;
- d. Convene regular monthly meeting for purposes of evaluating and coordinating the implementation of GAD Plan;
- e. Undertake continuing education and advocacy to promote Women's Economic, Social, and Political Development;



EXECUTIVE ORDER NO. 27

**PROVIDING FOR THE RE-ORGANIZATION OF THE PROVINCIAL GENDER AND
DEVELOPMENT (PGAD) COUNCIL DEFINING ITS DUTIES AND FUNCTIONS AND
APPROPRIATING FUNDS THEREFOR**

WHEREAS, Article II, Section 15 of the 1987 Constitution stipulates that "The State recognizes the role of women in the nation-building, and shall ensure the fundamental equality before law of women and men;"

WHEREAS, RA 7192, otherwise known as The Women in Nation Building Act directs all government agencies to institute measures that would eliminate gender biases in government policies, programs, and projects and to ensure that women are given means to participate fully in development and nation building;

WHEREAS, Executive Order No. 173, entitled Approving and Adopting the Philippine Plan for Gender Responsive Development, mandates all agencies to institutionalize Gender and Development (GAD) in the government by incorporating GADC concerns spelled out in the PPGD concerns in their agency performance commitment contracts, annual budget proposals and work and financial plans;

WHEREAS, there is a need for the Re-organization of the Provincial Gender and Development (PGAD) Council to ensure and sustain the Local Government Units' (LGUs) critical consciousness and support on women and gender issues and to take a lead in direction setting on mainstreaming GAD perspectives in the LGU programs, projects, activities, and processes.

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the following:

SECTION I. Organization of the Provincial GAD Council. The Provincial GAD Council of the Province of Occidental Mindoro is hereby organized to be constituted as follows:

Chairman	:	Hon. EDUARDO B. GADIANO Governor
Vice Chairman	:	SP Chairman on Family, Women, Children and Senior Citizens
Members	:	Provincial Planning and Development Officer

- a. Initiate the conduct of quarterly Provincial Nutrition Committee meetings;
- b. Lead the planning group within the PNC and initiate nutrition action planning;
- c. Coordinate implementation of the nutrition action plan and conduct periodic visits to municipalities and barangays to assess program implementation;
- d. Supervise Municipal and Barangay committees and act as resource person during Municipal and Barangay planning; and
- e. Prepare and submit report to the Provincial Governor and the PNC.

SECTION IV. Donations. The PNC shall be authorized to receive donations, grants, or gifts in whatever form and from whatever sources; provided that, said grants, gifts or donations shall be utilized in such manner as the majority of the PNC, may, in its discretion determine.

SECTION V. All laws, decrees, orders, rules and regulations inconsistent herewith are hereby repealed and/or modified accordingly.

SECTION VI. Effectivity. This Order shall take effect immediately.

SECTION II. Functions and Powers. The PNC shall have the following functions and powers:

- a. Formulate, coordinate, implement and monitor the nutrition program;
- b. Generate and mobilize resources;
- c. Integrate existing nutrition related projects and activities;
- d. Revitalize the Municipal and Barangay Nutrition Councils;
- e. Coordinate the release of public funds for nutrition purposes in accordance with the approved projects and programs; and
- f. Coordinate all requests for grants and/or aid from government agencies, non-government organizations and donor agencies involved in the nutrition program.

SECTION III. Provincial Nutrition Action Officer. The PNC shall appoint a Nutrition Action Officer who shall be the Focal Person and Head of Secretariat. The PNAO shall have the following responsibilities:

**PROVIDING FOR THE CREATION OF THE PROVINCIAL NUTRITION COMMITTEE (PNC) OF
OCCIDENTAL MINDORO, DEFINING ITS DUTIES AND FUNCTIONS, APPROPRIATING
FUNDS THEREFOR AND FOR OTHER PURPOSES**

WHEREAS, the DILG Memorandum Circular 2018-42 on the Adoption and Implementation of the Philippine Plan of Action for Nutrition (PPAN) 2017-2022 under Paragraph V, 1 (1.4) states the role of LGUs to organize, reorganize, and strengthen functional Local Nutrition Committee at the Provincial, City/Municipal/Barangay level with the Local Chief Executive as Chairperson through an enactment of a local ordinance that entails permanency;

WHEREAS, the Province of Occidental Mindoro is not an exemption to malnutrition which is seriously affecting millions of people in our country;

WHEREAS, malnutrition definitely retards mental and physical development of our children, weakens their resistance to infections resulting to unnecessary loss of human lives through high infant and child mortality rates;

WHEREAS, studies indicate that infants and young children, pregnant women, and nursing mothers are most vulnerable to malnutrition;

WHEREAS, the nutrition program, being concerned with human resource development, is a vital and integral part of the social reform and economic development;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

SECTION I. Creation of Provincial Nutrition Committee of Occidental Mindoro. There is hereby created under the Office of the Provincial Governor, the Provincial Nutrition Committee, hereinafter referred to as the PNC, to be composed of the following:

Vice-Chairman	:	Provincial Health Officer
Members	:	SP Chairman on Health
