

## "AMENDMENT TO EXECUTIVE ORDER NO. 29 SERIES OF 2019 (CREATING THE PROVINCIAL TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT (PTF-ELCAC) AND INSTITUTIONALIZING THE WHOLE-OF-NATION APPROACH IN ATTAINING INCLUSIVE AND SUSTAINABLE PEACE AND DEVELOPMENT)"

**WHEREAS,** Executive Order No. 29 was issued by the Provincial Governor of this Province creating the Provincial Task Force to End Local Communist Armed Conflict (PTF-ELCAC) to ensure efficient and effective implementation of the Whole-of-Nation approach as embodied in Executive Order No. 70 issued by His Excellency;
