**"AMENDMENT TO EXECUTIVE ORDER NO. 5 SERIES OF 2019
PROVIDING FOR THE RE-ORGANIZATION OF THE LOCAL HEALTH BOARD"**

WHEREAS, Executive Order No. 5 was issued by the Provincial Governor on August 7, 2019 providing for the composition of the Local Health Board;

WHEREAS, there is an imperative need to amend the composition of its members to include other officers/persons by virtue of the enactment of Republic Act No. 11223 otherwise known as "Universal Health Care Act" and the issuance of its Implementing Rules and Regulations;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the re-organization of the Provincial Health Board, as follows:

Section I. Amendment to Section I.- Section I of Executive Order No. 5 series of 2019 is hereby amended to read as follows:
