**Section VI. Secretariat.** There is hereby constituted for the Provincial Development Council a secretariat which shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions. The Provincial Development Council may avail the services of any NGO or educational or research institutions for this purpose, and shall be headed by the Provincial Planning Coordinator.

**Section VII. Relation of the Provincial Development Council to the Sangguniang Panlalawigan and the Regional Development Council.** The policies, programs, and projects proposed shall be submitted to the Sangguniang Panlalawigan for appropriate action.

The local development plans approved by the Sangguniang Panlalawigan may be integrated with the development plans of the Regional Development Council for submission to the National Economic and Development Authority, in accordance with the existing laws.

**Section VIII. Repealing Clause.** All prior issuances on the organization and function of the Provincial Development Council of Occidental Mindoro inconsistent herewith shall be deemed superseded by this order.

**Section IX. Effectivity.** The organization of the Provincial Development Council of the Province of Occidental Mindoro as herein provided shall take effect immediately.
