Section 2. Functions and Responsibilities

The functions and responsibilities of the Oversight Committee on the Revision of Fees and Charges are the following:

- 1. Ensure that the guiding principles as prescribed under the Local Government Code and this Joint Memorandum Circular are observed;
- 2. Review the rationale for fees and user charges imposed by the LGU and methodology for determination of the fee schedule or rates;
- Gather data on the cost of delivering regulatory, service fees and charges, in order to compute the appropriate rates that will recover the cost, using the LFC Toolkit;
- 4. Submit to the LCE and the Sanggunian the recommended proposed local revenue ordinance including a program of action to institute reforms.

EXECUTIVE ORDER NO. <u>74</u> Series of 2020

PROVIDING FOR THE CREATION OF AN OVERSIGHT COMMITTEE ON THE REVISION OF FEES AND CHARGES, DEFINING ITS DUTIES AND FUNCTIONS AND FOR OTHER PURPOSES

WHEREAS, the Department of the Interior and Local Government (DILG) and the Department of Finance (DOF) issued Joint Memorandum Circular (JMC) NO. 2019-01 dated May 17, 2019 providing for Guidelines for the Review, Adjustment, Setting and/or Adoption of Reasonable Regulatory Fees and Charges of Local Government Units;

WHEREAS, Item 6.4.1 of the above-mentioned Joint Memorandum Circular advises the Local Government Units to issue an Executive Order creating an Oversight Committee on the Revision of Fees and Charges;

WHEREAS, in view of the foregoing, there is an urgent need to promulgate this Executive Order to create an Oversight Committee on the Revision of Fees and Charges for the Province of Occidental Mindoro.

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor, Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Composition

There shall be created an Oversight Committee on the Revision of Fees and Charges in the Province of Occidental Mindoro which shall be composed of the following:
