- b. Provide technical assistance in the performance of administrative and technical tasks of the PPOC;
- c. Recommend and prepare PPOC agenda and other required documents during PPOC meetings;
- d. Prepare resolutions of the Council and the minutes of the meetings;
- e. Prepare and submit semestral PPOC Accomplishment Report to the NPOC, through the RPOC Secretariat;
- f. Prepare and submit quarterly Accomplishment Report to the NPOC, through the RPOC Secretariat;
- g. Formulate and adopt an effective mechanism for the coordination, cooperation, and consultation involving the local executives, citizenry and law enforcement agencies under R.A. 6975, as amended, in the adoption of the Community and Service-Oriented Policing (CSOP) System;
- h. Apply moral suasion to and/or recommend sanction against local chief executives who are giving material and political support to the insurgents;
- i. Monitor the provision of livelihood and infrastructure development programs and projects in the remote rural and indigenous population areas to isolate them from the insurgents' ideological, political, and organizational works;
- j. Create a Special Action Committee to address the immediate issues on peace and order and public safety, in case of emergencies;
- k. Create a Technical Working Group (TWG) for the purpose of POPS Planning, following the guidelines prescribed by the DILG on the tools and processes on POPS Planning;
- l. Submit semestral POC Accomplishment Report to the NPOC, through the respective POC Secretariats;
- m. Serve as a convergence mechanism to support the Enhanced Comprehensive Local Integration Program (ECLIP) Committee in its implementation, at the provincial level;
- n. Provide staff/s and financial support to POC Secretariat; and
- o. Perform such other functions as may be directed by law, the National Peace and Order Council, or the President.

Section VII. Meetings. A Quarterly meeting is to be held regularly. Dates and venues of the 4 quarterly meetings are to be set and disclosed by the Provincial Governor's Office.

Section VIII. Repealing Clause. All prior issuances of the organization and functions of the Peace and Order Council of Occidental Mindoro inconsistent herewith shall be deemed suspended by this Order.

Section IX. Effectivity. This Executive Order shall take effect immediately.

EXECUTIVE ORDER NO. 9
Series of 2019

**"PROVIDING FOR THE RE-ORGANIZATION/ AMENDMENT OF THE PROVINCIAL PEACE
AND ORDER COUNCIL (PPOC) OF OCCIDENTAL MINDORO"**

WHEREAS, Section 116 of Republic Act 7160 otherwise known as the Local Government Code of 1991, mandates the Local Government Units (LGUs) to establish a Local Peace and Order Council pursuant to Executive Order No. 309, as amended, Series of 1998;

WHEREAS, on January 5, 2009, the President of the Republic of the Philippines promulgated Executive Order No. 773, further amending Executive Order No. 309;

WHEREAS, there is a need for the re-organization of the Provincial Peace and Order Council of Occidental Mindoro due to tenure of office, re-assignment and election of the previous members of the council, to ensure more comprehensive and efficient coordination of provincial government efforts and active participation of citizens relative to the conduct of provincial campaign against criminality, insurgency and submersion;

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the power vested in me by law, do hereby order and direct to reorganize the **PROVINCIAL PEACE AND ORDER COUNCIL (PPOC)**.
