

EXECUTIVE ORDER NO. 3 Series of 2021

CREATION OF A SECRETARIAT TO THE INTER-AGENCY COMMITTEE ON THE RESTORATION OF OCCIDENTAL MINDORO RIVERS AND ITS TRIBUTARIES, COMPOSED OF REPRESENTATIVES FROM THE PROVINCIAL GOVERNMENT OF OCCIDENTAL MINDORO, PROVIDING FOR ITS FUNCTIONS AND FOR OTHER PURPOSES

WHEREAS, the Department of Environment and Natural Resources (DENR) issued DENR Administrative Order No. 2020-12 with the subject of Rationalizing Dredging Activities in Heavily-Silted River Channels within the Province of Occidental Mindoro pursuant to DENR-DPWH-DILG-DOTC Joint Memorandum Circular No. 1 Series of 2019;

WHEREAS, the Inter-Agency Committee on the Restoration of Occidental Mindoro Rivers and its Tributaries issued Resolution No. 6 Series of 2020 approving the creation of a Secretariat to be composed of representatives from the Provincial Government of Occidental Mindoro:

WHEREAS, in view of the foregoing, there is an imperative need to create a Secretariat composed of representatives from the Provincial Government of Occidental that shall be tasked with the initial assessment of the documents submitted by the proponents for dredging activities in the province of Occidental Mindoro.

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the CREATION OF A SECRETARIAT TO THE INTER-AGENCY COMMITTEE ON THE RESTORATION OF OCCIDENTAL MINDORO RIVERS AND ITS TRIBUTARIES COMPOSED OF REPRESENTATIVES FROM THE PROVINCIAL GOVERNMENT OF OCCIDENTAL MINDORO.

Section 1. CREATION. There is hereby created a Secretariat to the Inter-Agency Committee on the Restoration of the Occidental Mindoro Rivers and its Tributaries composed of representatives from the Provincial Government of Occidental Mindoro, as follows:

Section 2. DUTIES AND FUNCTIONS OF THE SERETARIAT.

- a) Conduct initial assessment and evaluation of the documents submitted by the proponents for river restoration through dredging activities in the province of Occidental Mindoro, using the checklist made by the Inter-Agency Committee (IAC);
- b) To forward the initial assessment and evaluation to the Inter-Agency Committee for endorsements/comments;
- To re-evaluate the documents sent to it by the Inter-Agency Committee. Said re-evaluation will be limited to the documents previously submitted by the proponents;
- d) To perform such other duties and functions as the Inter-Agency Committee may assign to it from time to time or as the need arises.

Section 3. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 4. REPEALING CLAUSE. All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 5. EFFECTIVITY. This Order shall take effect immediately.
