Section 4. There shall be a Section V of Executive Order No. 21 Series of 2019 which shall read, as follows:

"Section V. Duties and Functions of the PCCA Secretariat.

The Secretariat of the PCCA shall have the following duties and functions:

1. Provide administrative support to the PCCA;

2. Organize and make all necessary arrangements for the council meetings;

3. Attend council meetings;

4. Be the central channel of communication for the council with other line units of the agency, other government agencies, civil works and consulting services and the general public; and

5. Perform such other duties as the council may direct, as the circumstances arise."

Section 5. Separability Clause.

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 6. Repealing Clause.

All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 7. Effectivity. This order shall take effect immediately.

Section 2. Functions. The Provincial Council for Culture and the Arts shall have the following functions:

- a. Prepare an annual plan on culture, arts, and cultural heritage consonant with the Philippine Development Plan for Culture and the Arts, to be integrated in the local development plan and considered in the annual appropriation ordinances;
- b. Formulate policies and plans for the enrichment and sustainability of provincial unique cultural heritage;
- c. Create necessary committees for the Annual Foundation of the province;
- d. Shall serve as vehicle in cultivation of the talents and skills especially the youth;
- e. Conduct meetings in order to ensure the success of every relevant activity;
- f. Submit assessment reports on the status of every related activity to the Provincial Governor.

Section 3. Section IV of Executive Order No. 21 Series of 2019 is hereby amended to read, as follows:

“Section IV. Secretariat. There shall be created a Secretariat that shall provide the technical, logistic and administrative support to the Provincial Council for Culture and the Arts to be composed of the following:

AMENDMENT OF EXECUTIVE ORDER NO. 21 SERIES OF 2019 BY UPDATING THE NAMES OF MEMBERS OF THE PROVINCIAL COUNCIL FOR CULTURE AND THE ARTS (PCCA), THE MEMBERS OF THE SECRETARIAT AND PROVIDING FOR THE DUTIES AND FUNCTIONS OF THE SECRETARIAT AND FOR OTHER PURPOSES

WHEREAS, the Provincial Governor promulgated Executive Order No. 21 Series of 2019 on August 7, 2019 entitled "Providing for the Reorganization of the Provincial Council for Culture and the Arts (PCCA) of the Province of Occidental Mindoro, Defining its Duties, Functions, Appropriating Funds Therefor and for other Purposes";

WHEREAS, several members of the Provincial Council for Culture and the Arts were either retired, promoted, transferred to another office or whose tenure of office have already ended;

WHEREAS, in view of the foregoing, there is a need to promulgate this Executive Order to update the names of the members of the PCCA, the names of the members of the Secretariat and to provide for the duties and functions of the Secretariat.

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the following:
