**Section 2.** The Local Inter-Agency Committee on Housing & Resettlement shall convene immediately to discuss their plan of action. Ms. Joy C. Delfin, Provincial Housing Focal Person shall serve as the Secretariat of the LIAC.

**Section 3.** The functions of the Local Inter-Agency Committee on Housing and Resettlement are, but not limited to the following:

- a.) For the different government agencies and offices which are part of the Committee to converge and put their acts together in order to expedite the implementation of housing projects, the registration of lands to the intended beneficiaries, among others;
- b.) Coordinate with the Program Coordinating Committee and LGUs in the implementation of the projects for synchronization of policies and work plans;
- c.) Ensure that policies and processes of implementing agencies are consistent with local policies/ordinances;
- d.) Monitor the implementation and accomplishment of the plans, programs and projects by the implementing agencies and the concerned LGUs;
- e.) Ensure that the following utilities and services are provided for in each resettlement site: electricity, water supply, community facilities such health centers, school buildings, day care centers, multi-purpose halls, livelihood centers, market, tricycle and/or jeepney terminals, materials recovery facility, sewerage system, barangay or police outposts, evacuation centers, and the corresponding social services, and community development programs needed for building sustainable and resilient communities;
- f.) Facilitate access of additional resources that may be needed by the resettled families to complement the existing resources of the national government;
- g.) Facilitate, if necessary, inter-LGU dialogue between sending and receiving LGUs in the provision of additional resources to address the needs of the relocated families;
- h.) If necessary, provide legal and operational guidance to the LGUs in the exercise of their functions vis-a vis resettlement concerns; and
- i.) Perform such other functions that may be defined by the Committee.

**CREATING THE LOCAL INTER-AGENCY COMMITTEE ON HOUSING AND RESETTLEMENT  
IN THE PROVINCE OF OCCIDENTAL MINDORO, PROVIDING FOR ITS FUNCTIONS AND  
FOR OTHER PURPOSES**

**WHEREAS**, the Local Government Code of 1991 (RA 7160) and the Urban Development and Housing Act of 1992 (RA 7279) mandated the local government units to take the principal role in the provision of shelter and the delivery of basic services to its homeless and underprivileged constituents;

**WHEREAS**, Section 17 (b)(3)(viii) of the Implementing Rules and Regulations (IRR) of the Local Government Code of 1991 states that Provinces shall endeavor to implement programs and projects for low-cost housing and other mass dwellings;

**WHEREAS**, one of the flagship programs of the Provincial Government of Occidental Mindoro is the provision of decent and affordable shelter to its homeless and underprivileged constituents;

**WHEREAS**, the Province has identified potential sites suitable for housing and resettlement development purposes;

**WHEREAS**, there is a need to create a Local Inter-Agency Committee (LIAC) on Housing and Resettlement in the Province of Occidental Mindoro to facilitate the needed documentary processes and requirements for the smooth and orderly implementation of housing programs and projects in the province;

**NOW THEREFORE, I, EDUARDO B. GADIANO**, Governor, by virtue of the powers vested in me by law, do hereby create a Local Inter-Agency Committee (LIAC) on Housing and Resettlement in the Province of Occidental Mindoro.

**Section 1.** The Local Inter-Agency Committee on Housing and Resettlement shall be composed of the following:
