**EXECUTIVE ORDER NO. 49**

**AN ORDER MANDATING SUSPENSION OF CLASSES IN ALL LEVELS, BOTH PUBLIC AND PRIVATE, AND WORK IN ALL OFFICES, BOTH LOCAL AND NATIONAL AND PRIVATE ON JANUARY 13, 2020 (MONDAY) AS OF 1:00 PM IN THE MUNICIPALITIES OF ABRA DE ILOG, MAMBURAO, PALUAN, LOOC AND LUBANG, AS PRE-EMPTIVE MEASURE IN ANTICIPATION OF THE DAMAGING AND HAZARDOUS EFFECTS OF TAAL VOLCANO ERUPTION**

**WHEREAS**, the Province of Occidental Mindoro is currently experiencing adverse effects of Taal Volcano eruption in the form of ash fall, possible sulfur intoxication and other health threatening effects;

**WHEREAS**, these conditions are directly hazardous to health and well-being of the general public particularly on children and elderlies. It is the responsibility of the Provincial Government to ensure the safety and welfare of the people of Occidental Mindoro, pursuant to the General Welfare Clause of RA 7160 (the Local Government Code 1991);

**WHEREAS**, in anticipation of the disruptive effects as may be caused by this natural calamity, the safety and protection of all vulnerable sectors, especially school children, are our paramount concern;

**WHEREAS**, during the PDRRMC Emergency Meeting, it was strongly recommended by Ms. Teresa V. Tan, MD, OIC – Provincial Health Officer II and unanimously seconded by the the Provincial Disaster Risk Reduction and Management Council (PDRRMC) Members to suspend classes and work in all levels, both public and private; and office work, local and national, and private offices in anticipation of disastrous effects of this volcanic eruption;

**WHEREAS**, however, those positions and work that require frontline services like health providers and hospital staffs, those providing emergency and rescue operations, and jail operations are not covered by this Order;

**THEREFORE, I, EDUARDO B. GADIANO**, Provincial Governor, by virtue of the powers vested in me by Section 465 (b) (2) (iii), Article 1, Chapter 3, Book of RA7160, do hereby order the suspension of classes in all levels, both public and private, and work in offices, local and national and private on January 13, 2020 as of 1:00 PM in the Municipalities of Abra de Ilog, Mamburao, Paluan, Looc and Lubang as pre-emptive measures in anticipation of the disruption as may be caused by Taal Volcano eruption.

Done at the Provincial Capitol, Municipality of Mamburao, Province of Occidental Mindoro, this 13<sup>th</sup> day of January in the Year of Our Lord, Two Thousand and Twenty.

6. Promote to the LGUs adaptive management system with incentive and science based technical assistance to enhance local knowledge and capabilities.
7. Conduct of Monitoring and Evaluation on Rice Industry development and accomplishment in the municipal and barangay level prior to updating of the Plan and prepare Annual reports for filing and to the Provincial Governor and to the Sangguniang Panlalawigan.
8. Conduct of Impact Assessment/Analysis based on implemented project interventions from the PRCC Plan and make such recommendations for better innovation and implementation of the Plan.
9. Perform any other functions as may be prescribed by the Chairman/Governor.

### Section 3. MEETINGS

The Provincial Rice Coordinating Council shall be called for a meeting whenever it is necessary.

### Section 4. FUNDING REQUIREMENTS

#### 1. Project Implementation Funds:

All project interventions from the PRCC Plans are Proposal Based. Implementation funds shall be thru cost-sharing between the Provincial Government, Concerned Municipal Government and concerned National Government Agencies in accordance with their regular office programs.

#### 2. Operational Funds

All PRCC operational funding requirements including meetings shall be charged to any available funds of the Provincial Government.


#### 3. Transportation Expenses

Transportation expenses of PRCC members during meetings and other activities shall be charged to their respective offices.

### Section 5. EFFECTIVITY

This ORDER shall take effect immediately.

**Section 2. DUTIES AND FUNCTIONS OF THE PROVINCIAL RICE COMMODITY COUNCIL**

The Provincial Rice Commodity Council shall exercise the following duties, functions, and responsibilities:

1. The PRCC shall act as advisory, coordinating and consultative body of the Provincial Governor as the lead person.
2. Create and formulate Rice Development Plan and its financial requirements to fund the identified project interventions stipulated thereon and submit the same to the Provincial Governor's Office, Sangguniang Panlalawigan and to the Provincial Development Council for review, approval and adoption prior to implementation.
3. Link investment, marketing and entrepreneurial promotion and possibilities of accessing to financing.
4. Strengthen and empower rice farmers and concerned stakeholders to improve rice productivity for better and bigger income and profit that will help enhance socio-economic upliftment and poverty reduction in the localities.
5. Advocate and support existing enabling policy environment beneficial to the Rice Industry.

**PROVIDING FOR THE CREATION OF PROVINCIAL RICE COMMODITY COUNCIL FOR THE PROTECTION AND ENHANCEMENT OF SUSTAINABLE SOCIO-ECONOMIC GROWTH, DEVELOPMENT AND PRODUCTIVITY, DEFINING ITS FUNCTIONS, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES**

**WHEREAS**, the economy of the province of Occidental Mindoro is agriculture propelled and is known for its quality and sustainable productivity. Rice is the primary commodity grown by farmers and considered main source of livelihood, foods and income of concerned stakeholders involved in the Rice Industry;

**WHEREAS**, the rice productivity of the province under normal condition provides the farmers a remarkable average yield of 5.42MT/ha/cropping and delivers high percentage of production surplus of 340% which are distributed to nearby provinces, Metro Manila and other market demand centers that greatly contributed to fill up the gaps of rice requirements of these areas;

**WHEREAS**, this high performance level of the province in rice productivity was recognized and acknowledged by the National Government through the Department of Agriculture by awarding the province and concerned municipalities the GAWAD SAKA and Rice Achievers/Awards consistently for several years and is now holding the "HALL OF FAME AWARD";

**WHEREAS**, despite these multiple awards garnered, rice as a commodity, is still confronted by some issues and constraints such as climate related hazards ( EL NIÑO/ LA NIÑA), implementation of counter-productive laws and policies (Rice Tariffication), inconsistencies and weak political will of concerned government officials, instability of rice market pricing, absence of processing as value addition to rice, etc. All of these affect sustainable growth, productivity, income and profit of farmers and other stakeholders in the value chain of rice;

**WHEREAS**, during consultation meetings with Agriculture Stakeholders, it was strongly recommended the creation of the Provincial Rice Commodity Council who shall be responsible in the formulation and implementation of short and long term plans, programs and policies for the protection and strengthening of the Rice Industry and resolve issues affecting the Rice Sector;

**WHEREAS**, the Provincial Government of Occidental Mindoro, through the Honorable Governor Eduardo B. Gadiano, is responsible for the institutionalization of the Provincial Rice Commodity Council, through the issuance of Executive Order for its legal and binding implementation.

**NOW THEREFORE, I EDUARDO B. GADIANO**, Governor, Province of Occidental Mindoro, by the virtue of the powers vested in me by law, do hereby create the **Provincial Rice Commodity Council** for the protection and enhancement of sustainable socio-economic growth, development, and productivity.
