**Section 2. PRESENT ECQ GUIDELINES AND PROCEDURES OF THE MUNICIPALITY SHALL BE CONTINUOUSLY IMPLEMENTED.**

For the above purpose, all guidelines and procedures, through Executive Issuances, that the Municipality of San Jose are presently implementing under the Enhanced Community Quarantine (ECQ) shall be continued by the said Local Government Unit as long as these are pursuant to and consistent with the Issuances and Directives of the Inter-Agency Task Force For The Management of Emerging Infectious Diseases (IATF), of other National Government Agencies and Departments and the Executive Issuances of the Provincial Government.

**Section 3. SEPARABILITY CLAUSE.**

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

**Section 4. REPEALING CLAUSE.**

All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

**Section 5. EFFECTIVITY.**

This ORDER shall take effect from May 1, 2020 until May 15, 2020 unless earlier repealed or extended by another issuance.

**EXECUTIVE ORDER NO. 61**  
**Series of 2020**

**"AN ORDER IMPOSING ENHANCED COMMUNITY QUARANTINE IN THE MUNICIPALITY OF SAN JOSE, OCCIDENTAL MINDORO STARTING MAY 1, 2020 TO MAY 15, 2020"**

**WHEREAS**, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) issued Resolution No. 29 Series of 2020 on April 27, 2020 removing the Province of Occidental Mindoro from the list of provinces under Enhanced Community Quarantine (ECQ) and instead it will be placed under General Community Quarantine (GCQ) starting May 1, 2020 to May 15, 2020;

**WHEREAS**, pursuant to IATF Resolution NO. 29 Series of 2020, the Provincial Governor of this province promulgated Executive Order No. 60 Series of 2020 entitled "Guidelines and Procedures for the Implementation of General Community Quarantine (GCQ) starting May 1, 2020 to May 15, 2020 in the Province of Occidental Mindoro";

**WHEREAS**, despite the fact that the whole Province of Occidental Mindoro is placed under General Community Quarantine (GCQ), there is an urgent need for the Municipality of San Jose to be continuously under the Enhanced Community Quarantine (ECQ) considering that it has recorded a total of four (4) confirmed COVID-19 cases already and there are about 80 persons more (mostly healthcare workers and employees of San Jose District Hospital) whose COVID-19 tests are awaiting results.

**WHEREAS**, Mayor Romulo M. Festin of the Municipality of San Jose, Occidental Mindoro, through his letter addressed to MGEN Ruben L. Carandang, AFP (RET), Regional Director, OCD MIMAROPA, through Governor Eduardo B. Gadiano, requested that the Municipality of San Jose remain under Enhanced Community Quarantine (ECQ) citing its present predicament;

**WHEREAS**, in a meeting held among the members of the Provincial Department of Health Office, Provincial Inter-Agency Task Force on COVID-19 and PDRPMC, it was unanimously recommended that the Municipality of San Jose be placed under continuous Enhanced Community Quarantine due to the above-stated reasons.

**NOW, THEREFORE, I, EDUARDO B. GADIANO**, Governor, Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

**Section 1. IMPOSITION OF CONTINUOUS ENHANCED COMMUNITY QUARANTINE IN THE MUNICIPALITY OF SAN JOSE, OCCIDENTAL MINDORO.**

By the authority vested in Provincial Governors pursuant to Item B of IATF Resolution NO. 29 Series of 2020, it is hereby imposed that the Municipality of San Jose, Occidental Mindoro be continuously placed under the Enhanced Community Quarantine (ECQ) starting on May 1, 2020 until May 15, 2020, unless earlier withdrawn or extended, as circumstances may warrant and subject to re-evaluation and re-assessment.
