Section 2. Duties and Functions of the PPP Sub-Committee in the Provincial Development Council.

The PPP Sub-Committee shall discharge the following duties and functions:

- Assist the Provincial Government through the Provincial Development Council
 in setting the economic and social development, and coordinate the
 development efforts as provided for in Section 106 of the Local Government
 Code;
- 2. It shall, among others, assist the Provincial Development Council in the formulation of action plans and strategies related to the implementation of PPP programs and projects based on Executive Order No. 08 Series of 2010.

Section 3. Separability Clause.

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 4. Repealing Clause.

All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 5. Effectivity.

This ORDER shall take effect immediately.

EXECUTIVE ORDER NO. 80 Series of 2020

ESTABLISHMENT OF PRIVATE-PUBLIC PARTNERSHIP (PPP) SUB-COMMITTEE IN THE PROVINCIAL DEVELOPMENT COUNCIL (PDC) OF THE PROVINCE OF OCCIDENTAL MINDORO AND FOR OTHER PURPOSES

WHEREAS, Section 20, Article 5 of the 1987 Philippine Constitution and Section 1 of Republic Act No. 7718 otherwise known as the Build Operate Transfer (BOT) Law as amended, recognizes the role of the private sector as the main engine for national growth and development, and provides the most appropriate incentives to mobilize private resources for the purpose of financing infrastructure and development projects implemented by the government.

WHEREAS, Department of the Interior and Local Government Memorandum Circular No. 2011-16 enjoins all Local Government Units (LGUs) to create and establish a Public-Private Partnership (PPP) Sub-Committee in the Local Development Councils to assist the LGUs in setting economic and social development, and coordinate the development efforts as provided in Section 106 of the Local Government Code;

WHEREAS, in view of the foregoing, there is an imperative need to promulgate this Executive Order to create the Private-Public Partnership (PPP) Sub-Committee in the Provincial Development Council of the Province of Occidental Mindoro.

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor, Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Composition.

The Private-Public Partnership (PPP) Sub-Committee in the Provincial Development Council of the Province of Occidental Mindoro shall be composed of the following:
