RESOLUTION RECOMMENDING THE SEVEN (7) NOMINEES OF LOCAL DEVELOPMENT COUNCIL (LDC) TO THE PROVINCIAL PROJECT MONITORING COMMITTEE (PPMC) OF THE PROVINCE OF OCCIDENTAL MINDORO.

WHEREAS, as stated under Executive Order No. 376, series of 1989, amended by Executive Order No. 93, Series of 1993 provides for the establishment of the Regional Project Monitoring and Evaluation System (RPMES) as an institutionalized mechanism for monitoring and evaluation projects at the national, regional, provincial, and city/municipal levels;

WHEREAS, by virtue of memorandum Circular No. 175, Series of 1988 to the Project Monitoring Committee mandated to operationalize and implement the RPMES at the provincial, city, and municipal levels;

WHEREAS, DILG Memorandum Circular No. 2019-188 issued on November 14, 2019, directed the LGUs to organize or reconstitute Sub-Regional Project Monitoring Committees (PMCs) in their respective areas of jurisdiction, anchored on Republic Act 7160 (Local Government Code of 1991) which devolved functions of monitoring and evaluation (M & E) of programs projects to LGUs;

WHEREAS, in accordance with the said Memorandum Circular, the PMC will have, as mandatory members, the DILG representative or officer assigned in the locality; one (1) representative of NGOs/POs; one (1) representative of NGO/PO members in the LDC; and four (4) PMC members appointed by the Local Chief Executive from among five (5) nominees of the LDC;

WHEREAS, other members of the LPMC aside from the mandatory members shall be selected upon the discretion of the LDC, the Local Chief Executive shall appoint the chairperson from among the LDC nominees or the members of the PMC;
