**RESOLUTION EXPRESSING NO OBJECTION IN DEDUCTING THE LGUs' CONTRIBUTION TO THE COST OF THE PREPARATION OF TOURISM MASTER PLAN FROM THE LGUs' SHARE UNDER CONDITIONAL AUGMENTATION FUND FOR MUNICIPAL INITIATED PROJECTS (CAFMIIP).**

**WHEREAS**, last year, the Tourism Officer of the province made representation before the council and presented their initiative to pursue the preparation of Occidental Mindoro Tourism Master Plan;

**WHEREAS**, the crafting of the tourism master plan will entail a cost of about Twelve Million Pesos (P12 Million);

**WHEREAS**, through the Provincial Tourism Council where all municipal tourism officers are members, an agreement was reached that the LGUs will contribute to the cost of the preparation of the master plan subject to the specific requirement of the LGU;

**WHEREAS**, after a series of consultations with the key stakeholders, an agreement was forged within the Provincial Tourism Council that the contribution of each LGU is as follows:

Festin of San Jose, the Provincial Development Council hereby express no objection to the request of the tourism officers that the LGU contribution to the cost of crafting the Provincial Tourism Master Plan be taken from the shares of the LGUs in Conditional Augmentation Fund for Municipal Initiated Projects (CAFMIP).

**RESOLVED FURTHER,** that copies of this resolution be furnished the Sangguniang Panlalawigan of Occidental Mindoro for their appropriate action.
