RESOLUTION No. 6
Series of 2020

RESOLUTION APPROVING THE REQUEST OF SABLAYAN WATER DISTRICT FOR FINANCIAL ASSISTANCE IN TERMS OF A SOFT LOAN FOR THE EXPANSION OF LEVEL III WATER SYSTEMS IN SITIO PIANGA, BARANGAY LIGAYA AND BARANGAY PAETAN, BOTH OF SABLAYAN, THIS PROVINCE.

WHEREAS, access to water is recognized by the United Nations as human rights and that the lack of access to safe, sufficient and affordable water, sanitation and hygiene facilities has a devastating effect on the health, dignity and prosperity of billions of people, and has significant consequences for the realization of other human rights;

WHEREAS, Sablayan Water District was established on November 17, 1981 by virtue of Sangguniang Bayan Resolution No. 926, series of 1981 and since then, has been providing Level III water services in the municipality of Sablayan in accordance with Presidential Decree (PD) No. 198, 12 amended by PD Nos. 798 and 1479;

WHEREAS, Sablayan Water District aims to provide independent Level III water system in barangays exhibiting rapid urbanization;

WHEREAS, Sablayan Water District identified MEG AngSandigan Ville in Sitio Pianga, Barangay Ligaya, a socialize housing site for more than 260 families, and Barangay Paetan, both in Sablayan, as expansion sites of the water district;

WHEREAS, based on the cost estimates submitted by the water district, the two independent level III water systems will require investments of Three Million Pesos (Php 3,000,000.00) and Two Million Six Hundred Fifty Thousand Pesos (Php 2,650,000.00), respectively;

WHEREAS, the Board of Directors of Sablayan Water District, through its general manager, made representation before the council for funding assistance in terms of a soft loan.

NOW, THEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, on motion of MPDC Joseph Salgado, representing the mayor of San Jose, seconded by MPDC Randy Ramos, representing the mayor of Rizal, the Provincial Development Council hereby approves the request of Sablayan Water District for financial assistance in terms of a soft loan for the expansion of level III water systems in Sitio Pianga, Barangay Ligaya and Barangay
