RESOLUTION AMENDING PDC RESOLUTION No. 07 SERIES OF 2019 ENTITLED "RESOLUTION ADOPTING THE COMPOSITION AND INTERNAL RULES OF THE PROVINCIAL DEVELOPMENT COUNCIL (PDC)" AND ALLOWING IN SPECIAL CASES, THE VIRTUAL PARTICIPATION OF THE PDC MEMBERS DURING THE PROVINCIAL DEVELOPMENT COUNCIL MEETING.

WHEREAS, PDC Resolution No. 07 series of 2019 prescribed the internal composition and internal rules that govern the conduct of Provincial Development Council meeting;

RESOLVED FURTHER, that Section 5 of the Composition and Internal Rules of the Provincial Development Council is hereby amended to read:

"Section 5. Meetings and Quorum – The Provincial Development Council of Occidental Mindoro shall meet at least once every six (6) months or as often as necessary.

More than fifty percent (50%) of members in physical attendance constitute a quorum.

*On special cases like pandemics, natural and man-made disasters the Chairman may allow members to actively participate in the scheduled meeting via virtual platform and be considered present in the determination of quorum, **provided that the member made a request at least 3 days prior to the meeting.** Provided further, that a member may be **allowed attendance via virtual platform just once in a year.**"*

On such cases, the secretariat shall establish online platform and provide the requesting members access to the meeting."

RESOLVED FURTHERMORE, that copy of this resolution be furnished all members of the Council for their information and appropriate action.
