**RESOLUTION APPROVING THE GUIDELINES OF CONDITIONAL AUGMENTATION
FUND FOR MUNICIPAL INITIATED PROJECTS (CAFMIIP)**

WHEREAS, the Conditional Augmentation Fund For Municipal Initiated Projects (CAFMIIP) aims to provide a scheme to assist LGUs in good financial management standing in the delivery of basic government services and facilities, and encourage them to comply with the mandated plans and activities;

WHEREAS, a total of Fifty-Five Million Pesos (Php 55,000,000.00) from the 20% Development Fund of the Provincial Government shall be earmarked for this program to be shared by the 11 municipalities based on the criteria approved by the Council;

WHEREAS, all programs, projects, and activities qualified for investment under this program must conform to the allowable development projects as enumerated in the DILG-DBM joint Memorandum Circular No. 2017-1.

NOW, THEREFORE, be it RESOLVED as it is hereby RESOLVED, on motion of the Honorable Eric Labrador of Calintaan, duly seconded by Mr. Wilfredo Bleza, representative of the Honorable Michael Orayani of Lubang, the Provincial Development Council hereby approves the Guidelines of Conditional Augmentation Fund for Municipal Initiated Projects (CAFMIIP);

RESOLVED FURTHER, that copies of this resolution be furnished the Sangguniang Panlalawigan of Occidental Mindoro for their information and appropriate action.
