**RESOLUTION AFFIRMING THE APPROVAL OF RESOLUTIONS PASSED BY THE PROVINCIAL DEVELOPMENT COUNCIL-EXECUTIVE COMMITTEE (PDC-EXECOM)**

**WHEREAS,** as stated under section 111 (a) of RA 7160, provides the creation of Executive Committee to represent and act in its behalf when the PDC is not in session and act on matters requiring immediate attention or action by the council;

**WHEREAS,** it is stated under section 7, powers and functions in the composition and internal rules and procedures of the PDC-Executive Committee to formulate policies, plans and programs based on the general principles laid down by the council;

**WHEREAS,** the DILG-DBM Joint Memorandum Circular No. 2, dated March 30, 2020 issued to provides provisional guidelines on the preparation and approval of the AIPs and supplemental investment programs of LGUs to enable them to expeditiously undertake critical, urgent, and appropriate disaster response aid and measures to curtail and eliminate the threat of COVID-19, all COVID-19 related PPAs and expenses to be funded by the LGUs should be part of respective AIPs hence, the LDC is required to prepare supplemental investment program/s, to be approved by the local sanggunian;

**WHEREAS,** all programs, projects and activities passed by the committee are urgent projects and mostly Covid-19 related programs, projects and activities that there is a need to augment resources for the implementation of necessary measures to protect and prevent the spread of the corona virus in the province;
