A RESOLUTION APPROVING THE OCCIDENTAL MINDORO STATE COLLEGE (OMSC) CAMPUS DEVELOPMENT PROJECTS FOR INCLUSION IN THE FY2022 ANNUAL INVESTMENT PROGRAM (AIP) FOR FUNDING.

WHEREAS, Occidental Mindoro State Mindoro (OMSC) made a representation requesting for assistance in the development and improvement of their newly acquired lot adjacent to the current location of OMSC Mamburao Campus as part of its Land Use Development and Infrastructure Plan (LUDIP);

whereas, OMSC as the only state college in the province shall be provided with enough space and improved facilities and infrastructure that are conducive for learning, and to have an effective and efficient way of delivering its services to the stakeholders;

WHEREAS, the existing facilities and infrastructure of the OMSC Mamburao Campus is insufficient in attaining their vision;

WHEREAS, the OMSC-Mamburao acquired land adjacent to its existing campus for the extension of its infrastructure is intended to cater the increasing population of students that is projected to increase by 9,812 in the next ten years;
