RESOLUTION ENCOURAGING ALL SANGGUNIANG BAYAN (SB) TO PASS AN ORDINANCE ADOPTING THE VOLUNTARY GUIDELINES ON THE ESTABLISHMENT OF MUNICIPAL CATCH DOCUMENTATION AND TRACEABILITY SYSTEM TO PROPERLY MANAGE FISHERY RESOURCES

WHEREAS, pursuant to Rule 38.5 of the Implementing rules and regulations of republic Act No. 8550, as amended by Republic Act No. 10654, the Department of Agriculture-Bureau of Fisheries and Aquatic Resources (DA-BFAR) adopts the Voluntary Guidelines on the Establishment of a Municipal Catch Documentation and Traceability System for LGUs to manage Fishery Resources;

WHEREAS, the document shall serve as a guide for the LGUs in implementing the municipal catch documentation and traceability system to manage fishery resources in their area of jurisdiction;

WHEREAS, the general objective of this guideline is to establish a data collection system that is appropriate and viable at the local government level in order to provide management tool to prevent, deter and eliminate illegal, unreported and unregulated requirements and ensure continued market access of fish and fishery products;
