**PDC-PPOC JOINT RESOLUTION APPROVING THE CREATION OF THE
PROVINCIAL TASKFORCE TO END LOCAL ARMED CONFLICT AND
INSTITUTIONALIZING THE WHOLE-OF-NATION APPROACH IN ATTAINING
INCLUSIVE AND SUSTAINABLE PEACE AND DEVELOPMENT IN THE PROVINCE
OF OCCIDENTAL MINDORO.**

WHEREAS, Executive Order No.70 provides for the institutionalization of the Whole-Of-Nation Approach in attaining inclusive and sustainable peace, creation of national Task Force to End Local Communist Armed Conflict, and directs for the formulation of a National Peace Framework;

WHEREAS, the Whole-Of-Nation approach addresses the root causes of insurgencies, internal disturbances and tensions, and other armed conflicts and threat by prioritizing and harmonizing the delivery of basic services and social development packages by the government, facilitating societal inclusivity, and ensuring active participants of all sectors of the society in the pursuit of peace and development agenda;

WHEREAS, the MIMAROPA Regional Development Council and Regional Peace and Order Council in its joint meeting on March 28, 2019 adopted the Joint RDC-RPOC Resolution No. 01-2019 creating the Regional Task Force (RTF) that will spearhead and provide the directions in the operationalization of Executive Order No. 70 at the regional, provincial down to the grassroots level;

WHEREAS, the DILG Memorandum Circular No. 2019-125 entitled Guidelines for the Local Government Units in the implementation of Executive Order No. 70 Series of 2018 provides for the creation, composition, powers and functions of the **Provincial, City, Municipality and Barangay** Task to End Local Communist Armed Conflict;

NOW, THEREFORE, on motion duly seconded, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, a **Provincial Task Force/HUC** Task Force to End Local Communist Armed Conflict is hereby created whose organization and functions are provided as follows:

Section 1. Creation of the Provincial Task Force Task Force to End Local Communist Armed Conflict. To ensure efficient and effective implementation of the Whole-of-Nation approach, a Provincial Task Force to End Local Communist Armed Conflict (PTF ELCAC) is hereby created under the powers and functions of the National Task Force.

Section 2. Composition. The **Provincial Task Force** shall be composed of the Provincial Development Council and Provincial Peace and Order Council chaired by the **Provincial Governor**.

Section 3. Powers and Functions. The **Provincial Task Force** shall have the following duties and responsibilities:

1. Ensure the creation of City and Municipal Task Force which shall complement E.O No. 70 within their areas of jurisdiction;
2. Organize ad hoc inter-agency and multi-sectoral clusters, councils, committees, and groups at the Provincial level mirroring the 12 Clusters/Lines of Effort or modify existing ones whenever necessary to fulfill its mandates;
3. Take the lead in the localization of the 12 Clusters/Lines of Effort and the implementation of provincial plans in coordination with relevant national government agencies, LGUs, the civil society, and other stakeholders, guided by the Whole-Of-Nation approach-driven National Peace Framework;
4. Adhere to the feedback mechanism prescribed by the Regional Task Force and establish the same at the Provincial Level;
5. Ensure that Local Government Units (LGUs) include peace building initiatives as their priority in their Comprehensive Development Plan (CDP), Peace and Order and Public Safety (POPS) Plan and Local Development Investment Program (LDIP);
6. Ensure compliance to the monitoring and evaluation system provided by the Regional Task Force, and implement the same at the City/Municipal level to help track performance and analyze results for continuity and/or improvement;
7. Provide technical assistance to the City/Municipal Task Force as needed; and
8. Perform such other duties and functions as the President or the national/Regional Task Force may direct.

Section 6. Provincial Task Force Secretariat. The Provincial Task Force shall be assisted jointly by the **PDC and PPOC Provincial** Secretariat, to be headed by the PPOC Secretariat assisted by personnel from the member-agencies of the Task Force under secondment, detail, or other appropriate arrangement.

Section 7. Functions of the Provincial Task Force. The **Provincial Secretariat** shall have the following functions:

- a) Submit an organizational and staffing pattern and directory of the Provincial Task Force to the Regional Task Force within one (1) month from the creation of Task Force;
- b) Provide standard Secretariat services to the PTF; and

- c) Ensure proper coordination of initiatives among the clusters through the feedback mechanism established by the Task Force.

Section 8. Funding. The initial funding requirements for the implementation of this joint resolution shall be charged against existing appropriations of concerned Local Government Unit and member-agencies of the **Provincial** Task Force and such other appropriate funding sources as the Regional Task Force may provide, and when necessary, the Contingent Fund, subject to relevant laws, rules and regulations.

The succeeding year's appropriations for the operation of the **Provincial Secretariat** shall be included in the budget proposals of **PDC and PPOC**. The funding requirement for the implementation of the programs, plans and activities of the **Provincial Task Force** shall be included in the respective annual budget of the concerned agencies and/or Local Government Unit, subject to the usual budget preparation process.

NOW THEREFORE, on motion, duly seconded, **BE IT**.

RESOLVED, as is it hereby resolved the **Creation of the Provincial Task Force to End Local Communist Armed Conflict and Institutionalizing the Whole-Of-Nation Approach In Attaining Inclusive and Sustainable Peace and Development in the Province of Occidental Mindoro**.
