# EXECUTIVE ORDER NO. 10

## "AMENDMENT TO EXECUTIVE ORDER NO. 5 SERIES OF 2019 BY INCLUDING ADDITIONAL MEMBERS IN THE PROVINCIAL HEALTH BOARD OF OCCIDENTAL MINDORO AND FOR OTHER PURPOSES"

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991 mandates the organization of the Local Health Board;

WHEREAS, the health board composition is affected due to the tenure of office, reassignment and election in their respective fields;

WHEREAS, the Provincial Governor promulgated Executive Order No. 5 Series of 2019 on August 7, 2019 providing for the Reorganization/Amendment of the Local Health Board of the Province of Occidental Mindoro:

WHEREAS, there is a need to amend Executive Order No. 5 Series of 2019 so as to include additional members which are vital to the composition of the Provincial Health Board.

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

Section I. Composition. The following shall compose the Provincial Health Board:

#### Section II. Functions. The Provincial Health Board shall:

- Propose to the Sangguniang Panlalawigan, in accordance with the standard and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the province;
- 2. Serve as an advisory committee to the Sangguniang Panlalawigan on health matters and application of local appropriations for public health purposes;
- 3. Shall advise health agencies on technical and administrative standards of the Department of Health.

**Section III.** Meetings and Quorum. The board shall meet at least once a month or as often as may be necessary. Majority of the members shall constitute a quorum, but the chairman or the vice chairman must be present during meetings where budgetary proposals are being prepared and considered and the affirmative vote of the majority of the members shall be necessary to approve such proposals.

**Section IV. Secretariat.** There shall be constituted a secretariat responsible for providing technical and administrative support, documenting proceedings, preparing reports and providing such other assistance as may be required by the Provincial Local Health Board. The Secretariat shall be designated by the Governor as the Chairman of the Provincial Health Board.

**Section V. Separability Clause.** If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

**Section VI. Repealing Clause.** All Executive Orders, Memoranda, Circulars, letters of instruction and other issuance that are found to be inconsistent with the provisions of this Order are hereby repealed or modified accordingly.

Section VII. Effectivity. This Order shall take effect immediately.
