



EXECUTIVE ORDER NO. 17-A
Series of 2020

**AMENDMENT TO THE EFFECT OF CHANGING THE NAMES OF SOME MEMBERS OF
PROVINCIAL COUNCIL FOR THE PROTECTION OF CHILDREN (PCPC), THE SECRETARIAT
OF THE PCPC AND THE INTER-AGENCY MONITORING TASK FORCE OF THE PCPC IN THE
PROVINCE OF OCCIDENTAL MINDORO DUE TO RETIREMENT, PROMOTION, TRANSFER
AND TENURE OF OFFICE OF SOME MEMBERS**

WHEREAS, Executive Order No. 17 Series of 2019 was issued by the undersigned on August 7, 2019 creating the Provincial Council for the Protection of Children (PCPC), the Secretariat of the PCPC and the Inter-Agency Monitoring Task Force of the PCPC in the Province of Occidental Mindoro;

WHEREAS, there is an imperative need to effect an amendment on Executive Order No. 17 Series of 2019 in order to change the names of some members due to retirement, promotion, transfer and tenure of office of the previous members and as requested by the Provincial Council for the Protection of Children through its Resolution No. 01 Series of 2020.

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order an amendment to Executive Order No. 17 Series of 2019, as follows:

Section 1.

Section I of Executive Order No. 17 Series of 2019 is hereby amended to read, as follows:
