EXECUTIVE ORDER NO. 28
Series of 2022

**AN ORDER GRANTING HONORARIA TO THE MEMBERS OF THE PROVINCIAL MINING
REGULATORY BOARD (PMRB), AND FOR OTHER PURPOSES**

WHEREAS, pursuant to Section 24 of Republic Act No. 7076 (RA 7076) and Chapter VIII, Section 70 of Department of Environment and Natural Resources (DENR) Administrative Order No. 2010-21, applications for permit to extract certain mineral resources shall be accepted, processed and evaluated by the Provincial Mining Regulatory Board (PMRB) prior to its approval and issuance by the Provincial Governor;

WHEREAS, the effective implementation of relevant mining and environmental laws, rules, and regulations by the PMRB will generate significant additional revenues to the provincial and local governments of Occidental Mindoro;

WHEREAS, in accordance with Section 22, Chapter V of DENR Administrative Order No. 2015-03, the chairperson, members and secretariat of the Provincial Mining Regulatory Board (PMRB) shall receive compensation/honorarium based on meetings attended at the rate prescribed by pertinent laws subject to existing accounting and auditing procedures;

WHEREAS, in order for the PMRB to discharge its functions and responsibilities effectively, a PMRB Office shall be provided at the Provincial Capitol Building and funds shall be allocated for personnel and logistical support;

WHEREAS, Resolution No. 01, series of 2019 recommends the provision of honoraria for the PMRB Chairman and the DENR-MGB Technical Adviser/Staff to the Provincial Mining Regulatory Board (PMRB) of Occidental Mindoro;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by the law, do hereby order:

SECTION 1. COMPOSITION

Pursuant to RA 7076, DENR Administrative Order No. 2010-21 and its Implementing Rules and Regulations and other pertinent laws, the Provincial Mining Regulatory Board (PMRB) shall be composed of the following members:

SECTION 2. GRANTING OF HONORARIA.

SECTION 4. REPEALING CLAUSE.

All orders, rules and regulations issued by this province which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE.

This Order shall take effect immediately and shall remain in force until expressly revoked.
