**AN ORDER APPROVING THE GRANT OF MONTHLY STIPEND OF ONE THOUSAND FIVE HUNDRED PESOS (Php1,500.00) TO THE OFFICERS OF THE PROVINCIAL FEDERATION OF SENIOR CITIZENS ASSOCIATION AS PER REQUEST EMBODIED IN SP RESOLUTION NO. 48 SERIES OF 2015**

**WHEREAS**, Section 1 of Republic Act No. 9994 also known as the Expanded Senior Citizens Act of 2010, states that it is a declared policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provides adequate social services, promote full employment, a rising standard of living and an improved quality of life. In the Declaration of Principles and State Policies in Article II, Sections 10 and 11 of the 1987 Philippine Constitution, it is further declared that the State shall promote social justice in all phases of national development and that the State values the dignity of every human person and guarantees full respect for human rights;


**WHEREAS**, a Resolution from the Provincial Federation of Senior Citizens requesting for a monthly stipend for the officers amounting to one thousand five hundred (Php1,500.00) was presented for consideration by the Sangguniang Panlalawigan last February 24, 2015 during the 77<sup>th</sup> Regular Session of the Sangguniang Panlalawigan held at the Sangguniang Panlalawigan Hall, Provincial Capitol, Mamburao, Occidental Mindoro, and was resolved leading for a request to the Provincial Governor to grant the monthly stipend;

**WHEREAS**, as a token of appreciation, gratitude and financial augmentation to the Senior Citizens Provincial Federation Officers devotion in extending help to the Provincial Government of Occidental Mindoro to secure its smooth and effective implementation of plan, programs, projects and services for older persons in the whole Province of Occidental Mindoro, the said request for the grant of monthly stipend is hereby approved;

**WHEREAS**, Executive Order No. 46, series of 2019 was issued on November 26, 2019 providing for the grant of monthly stipend of One Thousand Five Hundred Pesos (Php1,500.00) to the officers of the Provincial Federation of Senior Citizens Association as per request embodied in SP Resolution No. 48, series of 2015.

**NOW THEREFORE, I, EDUARDO B. GADIANO**, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the **APPROVAL OF THE GRANT OF MONTHLY STIPEND OF ONE THOUSAND FIVE HUNDRED PESOS (Php1,500.00) TO THE OFFICERS OF THE PROVINCIAL FEDERATION OF SENIOR CITIZENS ASSOCIATION AS PER REQUEST EMBODIED IN SP RESOLUTION NO. 48 SERIES OF 2015.**
