



EXECUTIVE ORDER NO. 49
Series of 2022

“AN ORDER PROVIDING FOR THE REORGANIZATION OF THE PROVINCIAL ECOLOGICAL SOLID WASTE MANAGEMENT BOARD (PESWMB) OF OCCIDENTAL MINDORO AND RENAMING IT AS PROVINCIAL SOLID WASTE MANAGEMENT BOARD (PSWMB), AND FOR OTHER PURPOSES”

WHEREAS, it is the declared policy of the State to adopt a systematic and comprehensive solid waste management program which, among others, shall ensure the protection of public health and environment;

WHEREAS, Section 16, Article II of the Philippine Constitution provides that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, in accordance with Republic Act No. 7160, otherwise known as the “Local Government Code of 1991”, local government units shall be responsible for the implementation and enforcement of the provisions of the Ecological Solid Waste Management Act of 2000 within their respective jurisdictions;

WHEREAS, Republic Act 9003, otherwise known as the “Ecological Solid Waste Management Act of 2000” mandated the creation of Provincial Solid Waste Management Board in every province;

WHEREAS, Executive Order No. 8, series of 2019 was enacted providing for the creation of the Provincial Ecological Solid Waste Management Board (PESWMB) of Occidental Mindoro. The Board was reorganized by virtue of Executive Order No. 99, series of 2020;

WHEREAS, there is a need to further reorganize and update the composition of the Board and rename Provincial Ecological Solid Waste Management Board (PESWMB) into Provincial Solid Waste Management Board (PSWMB);

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the **REORGANIZATION OF THE PROVINCIAL ECOLOGICAL SOLID WASTE MANAGEMENT BOARD (PESWMB) OF OCCIDENTAL MINDORO AND RENAMING IT AS PROVINCIAL SOLID WASTE MANAGEMENT BOARD (PSWMB)**:

SECTION 1. RENAMING OF PROVINCIAL ECOLOGICAL SOLID WASTE MANAGEMENT BOARD (PESWMB) INTO PROVINCIAL SOLID WASTE MANAGEMENT BOARD (PSWMB).

The Provincial Ecological Solid Waste Management Board (PESWMB) of Occidental Mindoro is hereby renamed as Provincial Solid Waste Management Board (PSWMB) in compliance with Republic Act No. 9003 and its Implementing Rules and Regulations.

SECTION 3. FUNCTIONS OF THE PROVINCIAL SOLID WASTE MANAGEMENT BOARD (PSWMB) OF OCCIDENTAL MINDORO. The Provincial Solid Waste Management Board shall perform the following functions:

1. Develop a Provincial Solid Waste Management Plan from the submitted solid waste management plans of the respective 11 Municipal Solid Waste Management Boards.

It shall review and integrate the submitted plans of all its municipalities and ensure that the various plans complement each other, and have the requisite components.

The Provincial Solid Waste Management Plan shall be submitted to the Commission for approval.

The Provincial Plan shall reflect the general program of action and initiatives of the provincial government in implementing a solid waste management program that would support the various initiatives of its component municipalities.

2. Provide the necessary logistical and operational support to its component municipalities in consonance with subsection (f) of Sec. 17 of the Local Government Code;
3. Recommend measures and safeguards against pollution and for the preservation of the natural ecosystem;
4. Recommend measures to generate resources, funding and implementation of projects and activities as specified in the duly approved solid waste management plans;
5. Identify areas within its jurisdiction which have common solid waste management problems and are appropriate units for planning local solid waste management services in accordance with Section 41 of Republic Act No. 9003 – Criteria for Establishment of Sanitary Landfill;
6. Coordinate the efforts of the component municipalities in the implementation of the Provincial Solid Waste Management Plan;
7. Develop an appropriate incentive scheme as an integral component of the Provincial Solid Waste Management Plan;
8. Convene joint meetings of the Provincial and Municipal Solid Waste Management Boards at least every quarter for purposes of integrating, synchronizing, monitoring and evaluating the development and implementation of its provincial solid waste management plan;
9. Represent any of its component municipality in coordinating its resource and operational requirements with agencies of the national government;
10. Oversee the implementation of the Provincial Solid Waste Management Plan;
11. Review every two (2) years or as the need arises the Provincial Solid Waste Management Plan for purposes of ensuring its sustainability, viability, effectiveness and relevance in relation to local and international developments in the field of solid waste management; and
12. Allow for the clustering of LGUs for the solution of common solid waste management problems.

SECTION 4. SEPARABILITY CLAUSE.

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

SECTION 5. REPEALING CLAUSE.

All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately.
