



EXECUTIVE ORDER NO. 52
Series of 2022

AN ORDER AMENDING EXECUTIVE ORDER NO. 13, SERIES OF 2019, BY UPDATING THE LIST OF MEMBERS OF THE PROVINCIAL PRICE COORDINATING COUNCIL OF OCCIDENTAL MINDORO, AND FOR OTHER PURPOSES

WHEREAS, it is the policy of the state to ensure the availability of basic necessities and prime commodities at reasonable prices at all times without denying legitimate business a fair return on investment;

WHEREAS, DILG Memorandum Circular dated March 26, 2008, addressed to all Provincial Governors, City and Municipal Mayors, DILG Provincial Directors, City and Municipal Local Government Operations Officers and others concerned, mandates the Local Government Units to reactivate the Local Price Coordinating Council (LPCC) in order to help ensure the availability of basic goods to consumers and prevent unreasonable price increases. It is likewise the concern of the State to provide protection to consumers against hoarding, profiteering, and cartels of said goods particularly in times of crisis, calamities, emergencies, widespread illegal manipulation and similar situations;

WHEREAS, the formulation of LPCCs at the provincial, city, and municipal levels is in line with Section 55, Rule VI of the Implementing Rules and Regulations of RA 7581, otherwise known as "An Act Providing Protection to Consumers by Stabilizing the Prices of Basic Commodities " and DILG Memorandum Circular No. 2001-121.

WHEREAS, several members of the Provincial Price Coordinating Council (PPCC) were either retired, promoted, transferred to another office or whose tenure of office have already ended;

WHEREAS, in view of the foregoing, there is a need to promulgate this Executive Order to update the names of the members of the PPCC;

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order that the Provincial Price Coordinating Council (PPCC) of Occidental Mindoro be organized.

Section 1. Amendment. Section I of Executive Order No. 13, Series of 2019 is hereby amended to read as follows:
