



EXECUTIVE ORDER NO. 53

AN ORDER AMENDING EXECUTIVE ORDER NO. 28, SERIES OF 2019, BY UPDATING THE MEMBERS OF THE PROVINCIAL NUTRITION COMMITTEE (PNC) OF OCCIDENTAL MINDORO, AND FOR OTHER PURPOSES

WHEREAS, the DILG Memorandum Circular 2018-42 or the Adoption and Implementation of the Philippine Plan of Action for Nutrition (PPAN) 2017-2022 under Paragraph V, 1 (1.4) states the role of LGUs to organize, reorganize, and strengthen functional Local Nutrition Committee at the Provincial, City/Municipal/Barangay level with the Local Chief Executive as Chairperson through an enactment of a local ordinance that entails permanency;

WHEREAS, the Province of Occidental Mindoro is not an exemption to malnutrition which is seriously affecting millions of people in our country;

WHEREAS, malnutrition definitely retards mental and physical development of our children, weakens their resistance to infections resulting to unnecessary loss of human lives through high infant and child mortality rates;

WHEREAS, studies indicate that infants and young children, pregnant women, and nursing mothers are most vulnerable to malnutrition;

WHEREAS, the nutrition program, being concerned with human resource development, is a vital and integral part of the social reform and economic development;

WHEREAS, several members of the Provincial Nutrition Committee (PNC) were either retired, promoted, transferred to another office or whose tenure of office have already ended;

WHEREAS, in view of the foregoing, there is a need to promulgate this Executive Order to update the names of the members of the PNC;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Amendment. Section I of Executive Order No. 28 Series of 2019 is hereby amended to read as follows:
