EXECUTIVE ORDER NO. 55-A
Series of 2022

**AN ORDER RECONSTITUTING THE LOCAL HEALTH BOARD OF THE PROVINCE OF
OCCIDENTAL MINDORO, ITS TECHNICAL WORKING GROUP (TWG), PROVIDING FOR
THEIR DUTIES AND FUNCTIONS, AND FOR OTHER PURPOSES**

WHEREAS, Article 185 of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act 7160) mandates the creation of the Local Health Board (LHB);

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and there shall be priority for the needs of the underprivileged, sick, elderly, disabled, women, and children;

WHEREAS, the recent local elections require reconstitution of the LHB due to the end of term of office of former LHB members; and

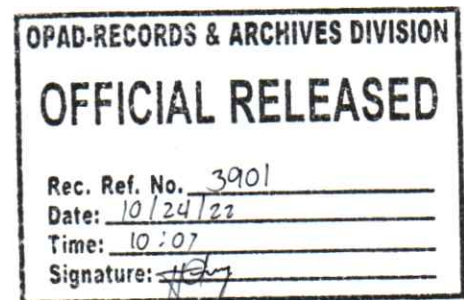
WHEREAS, based on the above premises, the Provincial Government would like to ensure the seamless transition to the new administration including the continuity of the functions and programs of the LHB;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Provincial Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by the law, do hereby order the reconstitution of the LHB of the province of Occidental Mindoro with the following stipulations:

Section 1. Composition

The Local Health Board of the province of Occidental Mindoro shall be composed of the following:

Section 3. Duties and Functions of the Local Health Board (LHB)

The LHB shall perform the following functions:

- a) Propose to the Sanggunian concerned, in accordance with the standards and criteria set by DOH, annual budgetary allocations for the operation and maintenance of health facilities and services within the province, as the case may be;
- b) Serve as an advisory committee to the Sanggunian concerned on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes; and
- c) Create committees which shall advise, local health agencies on matters such as, but not limited to, technical and administrative standards of DOH, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, budget review, operations review and similar functions.

Section 4. Functions of Technical Working Group (TWG)

The TWG shall act as an advisory committee to the LHB and undertake necessary activities pursuant to UHC Act, its Implementing Rules and Regulations (IRR), and other related national policies and guidelines, to wit:

1. Advocate for the integration of the local health systems;
2. Convene the key stakeholders in the province to discuss and agree on the need to develop a PWHS as part of ensuring quality, affordable, comprehensive, and efficient health care in the province;
3. Coordinate with the Department of Health (DOH) and other partners for health to secure assistance needed towards the institutionalization of the PWHS;
4. Assist in the conduct of preparatory works needed to facilitate the organization of the PWHS, such as mapping of the service capabilities of health facilities and services including the status of DOH license and Philhealth accreditation, and catchment populations; drafting of operational guidelines and other technical documents; conduct of baseline assessment, among others;
5. Assist in the managerial, technical and financial integration of the local health system, including the monitoring of implementation and functionality of the management support system such as:
 - a. Strategic and investment planning;
 - b. Human resources for health management and development system;
 - c. Information system, including interoperable electronic medical records system among health providers;
 - d. Epidemiology and surveillance system;
 - e. Logistics and supply chain management;
 - f. Functional two-way referral system;
 - g. Disaster risk reduction management for the health systems; and
 - h. Implementation of proactive and effective health promotion programs or campaigns;
6. Recommend to the LHB the consideration for the equitable distribution of the SHF
7. Advocate for public-private partnerships to facilitate complementation of efforts;
8. Create technical sub-committees, as deemed necessary; and
9. Perform such other functions and acts as may be necessary, proper, and incidental to the attainment of its objectives.

Section 5. Secretariat. The Provincial Health Office (PHO) shall serve as the secretariat of the TWG. They shall perform the following duties and functions:

1. To provide communication, coordination, and liaison support to all activities of the TWG
2. To perform record management of all documents and such other functions and acts as may be necessary.

Section 6. Meetings and Quorum

- a) The LHB shall meet at least once a month or as often as may be necessary.
- b) A majority of the members of the board shall constitute a quorum, but the chairperson or the vice chairperson must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of a majority of the members present shall be necessary to approve such proposals.

Section 7. Budget

The local health board budget shall give priority to the following:

- a) Conduct of quarterly board meetings
- b) Travelling expenses and allowances of monitoring and evaluation team and/or Technical Working Group as designated by the board through a resolution
- c) Conduct of TWG meetings
- d) Travelling expenses and allowances/communication expenses of CSO representatives to the Local Health Board
- e) Other allowable expenses as may be authorized by the council.

Section 8. Compensation and Remuneration

The co-chairpersons and members of the provincial health board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary traveling expenses and allowances chargeable against the funds of the LHB, subject to existing accounting and auditing rules and regulations.

Section 9. Repealing Clause

All Executive Orders or issuances issued by the Provincial Government inconsistent with the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 10. Effectivity

This Executive Order shall take effect immediately.
