

#### **EXECUTIVE ORDER NO. 6-A**

# "AMENDMENT TO THE COMPOSITION OF THE PROVINCIAL DEVELOPMENT COUNCIL OF THE PROVINCE OF OCCIDENTAL MINDORO AND OF ITS SECTORAL FUNCTIONAL COMMITTEES"

WHEREAS, Executive Order No. 6 was issued by the Provincial Governor on August 7, 2019 providing for the re-organization of the Provincial Development Council;

WHEREAS, there is an imperative need to amend some sections of Executive Order No. 6 to include additional members to the Council and to modify the composition of some of the Sectoral Functional Committees due to retirement and re-assignment of some members;

**NOW, THEREFORE, I, EDUARDO B. GADIANO,** Governor of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the following:

Section III. Section VI of Executive Order No. 6 is hereby amended to read, as follows;

"Section V. Secretariat. There shall be a secretariat composed of the personnel from Provincial Planning and Development Office and an officer or faculty member of the Occidental Mindoro State College (OMSC). They shall be responsible for providing technical and administrative support, documenting proceedings, preparing reports and providing such other assistance as may be required by the Provincial Development Council. The Secretariat shall be designated by the Governor as the Chairman of the Provincial Development Council."



Section IV. Effectivity. This Executive Order shall take effect immediately.
