



**EXECUTIVE ORDER NO. 61**  
Series of 2022

**"REORGANIZATION OF THE PROVINCIAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (PCAT-VAWC), DEFINING ITS DUTIES AND FUNCTIONS."**

**WHEREAS**, Republic Act No. 9208 or otherwise known as Anti-Trafficking in Persons Act of 2003, as amended by RA 10364 also known as the Expanded Anti-Trafficking in Persons Act of 2012 declares that the State shall give highest priority to the enactment of measures and development programs that will promote human dignity, protect the people from violence and exploitation, eliminate trafficking in persons, and mitigate pressures for involuntary migration and servitude of persons to ensure their recovery, rehabilitation and integration;

**WHEREAS**, Republic Act No. 9262 or otherwise known as Anti-Trafficking Against Women and their Children Act of 2004 underscores the commitment of the State in safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security;

**WHEREAS**, the two laws provide stronger mandates and direction to relevant government agencies and stakeholders to immediately address human trafficking and VAWC by organizing committee on Anti-Trafficking and VAWC at the provincial level.

**WHEREAS**, "Provincial Committee on Anti-Trafficking and Violence Against Women and their Children (PCAT-VAWC)" there is a need to reorganize the existing to update the membership.

**NOW THEREFORE, I, EDUARDO B. GADIANO**, Governor of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the REORGANIZATION OF THE PROVINCIAL PCAT-VAWC COMMITTEE in the Province of Occidental Mindoro.

**Section I. Composition.** The Provincial Committee on Anti-Trafficking and Violence Against Women and their Children (PCAT-VAWC), shall be composed of the following:

**Section II. Duties and Functions of the Council.** The PCAT VAWC Council shall perform the following duties and functions:

1. Institute policies and programs to protect women and children who are victims of trafficking and violence (formulate local resolutions);
2. Create and establish systems on surveillance, investigation, and rescue to ensure effective and efficient coordination;
3. Undertake information, education, and advocacy campaign against trafficking in persons and Violence Against Women and their Children (VAWC) effective; and
4. Monitor and oversee the strict implementation of RA 9208, as amended, RA 9262, as amended and other related laws for the protection of women and children, and of the Inter-Agency Council Against Trafficking (IACAT) and Inter-Agency Council on Violence Against Women and their Children (IACVAWC) national plans and actions.

**Section III. Secretariat.** There shall be a Provincial PCAT VAWC Secretariat which shall provide administrative and technical support to the council.

The Secretariat of the Council shall be composed of the following:

Secretariat	- <b>Rosalina R. Lamoca, RSW</b>
Technical Support Staff	- <b>Arnel G. Medico, RSW</b> - <b>Wilma P. Tadeja</b> - <b>Diana Rose A. Mugat, RN</b>

The Secretariat shall have the following functions:

- a. Provide administrative support to the council;
- b. Organize and make all necessary arrangements for the council meetings;
- c. Attend council meetings;
- d. Be the central channel of communication for the council with other line units of agency, other government agencies, civil works and consulting services, and the general public.
