**EXECUTIVE ORDER NO. 63**

**AN ORDER PROVIDING FOR THE REORGANIZATION OF THE PROVINCIAL ANTI-DRUG ABUSE COUNCIL (PADAC) IN THE PROVINCE OF OCCIDENTAL MINDORO AND FOR OTHER PURPOSES**

**WHEREAS**, it is the policy of the State to safeguard the integrity of its territory and the well-being of its citizenry particularly the youth, from the harmful effects of dangerous drugs on their physical and mental well-being, and to defend the same against acts or omissions detrimental to their development and preservation;

**WHEREAS**, Republic Act No. 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, called for the active participation of Local Government Units (LGUs) in the implementation of its provisions, giving priority to preventive or educational programs and the rehabilitation or treatment of drug dependents;

**WHEREAS**, Section 16 of the Local Government Code of 1991 provides that local government units shall pursue undertaking to improve public morals and maintain peace and order, among other equally significant concerns;

**WHEREAS**, Joint Memorandum Circular (JMC) No. 2018-01, entitled "Implementing Guidelines on the Functionality and Effectiveness of Local Anti-Drug Abuse Councils" provides for the creation/reorganization of Local Anti-Drug Abuse Councils (ADACs) to address illegal drug use problem in the country;

**WHEREAS**, there is an increasing use of illegal drugs which has significantly contributed to the incidence of heinous crimes. The problem in illegal drugs has to be addressed much more effectively to ensure community peace and harmony;

**WHEREAS**, the Provincial Governor issued Executive Order No. 15, series of 2019, providing for the reorganization of the Provincial Anti-Drug Abuse Council (PADAC) in the Province of Occidental Mindoro;

**WHEREAS**, in view of changes in some of the members of the PADAC, there is a compelling need to further reorganize the said Council;

**NOW THEREFORE, I, EDUARDO B. GADIANO**, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the **REORGANIZATION OF THE PROVINCIAL ANTI-DRUG ABUSE COUNCIL (PADAC) IN THE PROVINCE OF OCCIDENTAL MINDORO**

**SECTION 2. ROLE AND RESPONSIBILITIES OF THE PADAC.** The Provincial Anti-Drug Abuse Council shall form the following roles and responsibilities:

- a. Ensure the formulation of PADAC Action Plan that contains the PPAs identified in the Municipal and City ADAC Action Plans;
  1. Organize the PADAC Drug Reformation Committee and adopt the Program of Instructions for Drug Reformation Program;
- b. Approve substantial amount of budget;
- c. Ensure the functionality of the lower ADACs;
- d. Conduct of regular meetings once a month;
- e. Analyze and review reports submitted by CADAC/MADAC Secretariat;
- f. Submit all collated quarterly reports to the RPOC Secretariat not later than the 15<sup>th</sup> day of the ensuing quarter, copy furnished the Provincial Peace and Order Council

For the Period	Deadline of Submission
1 <sup>st</sup> Quarter	Not later than the 15 <sup>th</sup> day of April
2 <sup>nd</sup> Quarter	Not later than the 15 <sup>th</sup> day of July
3 <sup>rd</sup> Quarter	Not later than the 15 <sup>th</sup> day of October
4 <sup>th</sup> Quarter	Not later than the 15 <sup>th</sup> day of January of the ensuing year

- g. Ensure the establishment and operation of the Special Drug Education Center for out of school youth (OSY) and street children;
- h. Provide support for the operationalization of the Community-Based Rehabilitation Program at the Municipality and Component Cities.

**SECTION 3. PADAC Meetings.** The Provincial Anti-Drug Abuse Council (PADAC) shall convene on a quarterly basis, or as often as needed. There shall be minutes of the meeting to be prepared on each meeting.

**SECTION 4. FUNDS.** The activities, programs and projects of Anti-Drug Abuse Council shall be incorporated in the Provincial Peace and Order Plan.

**SECTION 5. SEPARABILITY CLAUSE.**

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

**SECTION 6. REPEALING CLAUSE.**

All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.
