**EXECUTIVE ORDER NO. 79**  
**Series of 2020**

**"AN ORDER IMPOSING MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN  
THE PROVINCE OF OCCIDENTAL MINDORO STARTING SEPTEMBER 1, 2020 UNTIL  
SEPTEMBER 30, 2020"**

**WHEREAS**, Article II, Section 15 of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) issued Resolution No. 67 dated August 31, 2020 placing the Province of Occidental Mindoro among the areas under Modified General Community Quarantine (MGCQ) from September 1, 2020 until September 30, 2020;

**WHEREAS**, in view of the foregoing, there is an urgent need to promulgate this Executive Order to impose Modified General Community Quarantine in the Province of Occidental Mindoro from September 1, 2020 until September 30, 2020.

**NOW, THEREFORE, I, EDUARDO B. GADIANO**, Governor, Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

**Section 1. IMPOSITION OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN THE PROVINCE OF OCCIDENTAL MINDORO.**

Pursuant to IATF Resolution No. 67 dated August 31, 2020, the Province of Occidental Mindoro is hereby placed under Modified General Community Quarantine (MGCQ) starting on September 1, 2020 until September 30, 2020.

**Section 2. MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ).**

Modified General Community Quarantine (MGCQ) refers to the transition phase between GCQ and New Normal, when the following temporary measures are relaxed and become less necessary: limiting movement and transportation, the regulation of operating industries, and the presence of uniformed personnel to enforce community quarantine protocols.

**Section 3. EXECUTIVE ORDER NO. 69 SERIES OF 2020 OF THE PROVINCE, IATF OMNIBUS GUIDELINES AND OTHER NATIONAL ISSUANCES RELATIVE TO MGCQ SHALL BE CONTINUOUSLY IMPLEMENTED.**

For the above purpose, Executive Order No. 69 Series of 2020 issued by the Provincial Government, IATF Omnibus Guidelines and all other Orders, Resolutions and Guidelines issued by the National Government relative to Modified General Community Quarantine shall still apply and shall be continuously implemented.

**Section 4. ENFORCEMENT OF THE FOLLOWING MEASURES.**

The Province and its Municipal LGUs shall observe strict enforcement of the following measures:

- a.) Minimum public health standards, especially uniform implementation in high-risk areas such as healthcare settings, wet markets, supermarkets, government offices, and workplaces, among others;
- b.) Localized community quarantine and availability of identified quarantine facilities in priority/critical areas with community transmission, including private and public establishments, with concurrence of the RIATF;
- c.) Immediate facility-based isolation of all returning citizens, suspect, and probable cases;
- d.) Scaling up of local health system capacity, especially for community isolation and critical care, including dedicated mechanical ventilators, ICU, isolation, and ward beds for COVID-19 cases;
- e.) Submission of complete and accurate data through COVID-Kaya and DOH DataCollect.

**Section 5. SEPARABILITY CLAUSE.**

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.


**Section 6. REPEALING CLAUSE.**

All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

**Section 7. EFFECTIVITY.**

This ORDER shall take effect from September 1, 2020 until September 30, 2020 unless earlier repealed or extended by another issuance.
