**AMENDMENT TO EXECUTIVE ORDER NO. 84 SERIES OF 2020 TO THE EFFECT OF
CHANGING THE COMPOSITION OF THE MEMBERS OF LOCAL ROAD NETWORK
DEVELOPMENT PLAN (LRNDP) TECHNICAL WORKING GROUP (TWG) FOR THE
PROVINCE OF OCCIDENTAL MINDORO AND FOR OTHER PURPOSES**

WHEREAS, Section 17 (a) and 17 (b) (3)(vii) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 mandates Local Government Units to provide basic services and facilities, including infrastructure such as roads and bridges;

WHEREAS, DILG issued Memorandum Circular No. 2017-159 mandating local chief executives (LCEs) to prepare LRNDPs as a comprehensive response to address the “decades-long underinvestment in local roads”;

WHEREAS, Local Road Network Development Plan (LRNDP) is an integrated 5-year plan for the sustainable management of local road networks, supported by multi-year Investment Program. The LRNDP is a requirement for provinces to access funding for road infrastructure development under the CMGP Program;

WHEREAS, DILG issued Memorandum Circular No. 2020-119 dated September 7, 2020 entitled “Guidelines on the Enhancement of the Local Roads Network Development Plan (LRNDP)” the purpose of which is to guide all Local Government Units, within the area of their component units, in preparing the Local Road Network Development Plan (LRNDP), in collaboration with business sector organizations and other stakeholders;

WHEREAS, the undersigned issued Executive Order No. 84 Series of 2020 on October 12, 2020 creating the Local Road Network Development Plan (LRNDP) Technical Working Group (TWG) for the Province of Occidental Mindoro.

WHEREAS, there is a need to amend Section 1 of Executive Order No. 84 Series of 2020 to change the composition of the members of the LRNDP Technical Working Group.

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor, Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. AMENDMENT TO SECTION 1 OF EXECUTIVE ORDER NO. 84 SERIES OF 2020.

Section 1 of Executive Order No. 84 Series of 2020 is hereby amended to read, as follows:

“Section 1. CREATION OF LOCAL ROAD NETWORK DEVELOPMENT (LRNDP) TECHNICAL WORKING GROUP (TWG) AND ITS COMPOSITION.

The Local Road Network Development Plan (LRNDP) Technical Working Group (TWG) for the Province of Occidental Mindoro is hereby created. Its composition shall be, as follows:

Section 2. DUTIES AND FUNCTIONS OF LOCAL ROAD NETWORK DEVELOPMENT PLAN (LRNDP) TECHNICAL WORKING GROUP (TWG).

The Local Road Network Development Plan (LRNDP) Technical Working Group (TWG) shall have the following duties and functions:

1. To facilitate, provide inputs and recommendations on enhancing the LRNDP to ensure that all Local Road Investment Programs of all levels of LGUs within the jurisdiction of the province are included in the integrated LRNDP;
2. To ensure participation of the Municipal LGUs in the formulation of LRNDP;
3. To ensure participation and representation of the business sector and civil society organizations in the formulation of LRNDP and the adoption of applicable tools and approaches on socio-economic analysis to determine core road networks for investment;
4. Such other functions as the Provincial Governor may direct them to perform, as the need arises.

Section 3. SEPARABILITY CLAUSE.

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.
