**AN ORDER CREATING THE PROVINCIAL PEACE PANEL IN THE PROVINCE OF
OCCIDENTAL MINDORO, DEFINING ITS DUTIES AND FUNCTIONS AND FOR OTHER
PURPOSES**

WHEREAS, President Rodrigo Roa Duterte issued Executive Order No. 70, entitled "Institutionalizing the Whole of the Nation Approach in Attaining Inclusive and Sustainable Peace, Creating a National Task Force to End Local Communist Armed Conflict and Directing the Adoption of a National Peace Framework" on December 4, 2018, in line with policy of inclusive and sustainable peace;

WHEREAS, Executive Order No. 70 encourages the formulation of a mechanism for local peace engagements or negotiations or interventions that is nationally orchestrated, directed and supervised, while being locally implemented;

WHEREAS, on April 15, 2019, NTF-ELCAC approved the implementation plans of the Executive Order 70 to carry out its mandates. The Implementation Plan of the Local Peace Engagement (LPE) Cluster provides for the issuance of Guidelines for the Conduct of Local Peace Engagements as part of the policy framework for this initiative;

WHEREAS, on August 06, 2019, the Local Peace Engagement Cluster, through the Chairmanship of DILG and Co-Chairmanship of OPAPP, has finalized the Guidelines for the Conduct of Local Peace Engagements. Two-track approach for localization was formulated. Track 2, under which Provincial Peace Panel falls, involves local peace dialogues between the local peace panel and Communist Terrorist Group.

WHEREAS, in view of the foregoing, there is an imperative need to issue an Executive Order creating a Provincial Peace Panel in the Province of Occidental Mindoro.

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the creation of Provincial Peace Panel, defining its duties and functions, and for other purposes.

Section 1. CREATION. The Provincial Peace Panel in the Province of Occidental Mindoro is hereby created. It shall be composed of the following:

- ii. The resolution of any issue or the response to any demand shall always be within the bounds of the Philippine Constitution and the ambit of the law;
 - iii. The local peace panel, through the RTF-ELCAC/CORDS, shall consult the NTF-ELCAC regarding any demand or issue that involves a question of national policy or security prior to making any commitment;
 - iv. Provide regular progress reports to the NTF-ELCAC, through the RTC-ELCAC/CORDS, regarding the status of local peace engagements.
- g. Submit to the NTF-ELCAC, through RTF-ELCAC/CORDS, the draft joint local-level peace agreement, for approval;
 - h. Sign the joint local-level peace agreement;
 - i. Implement agreements;
 - j. Monitor and evaluate compliance to agreements; and
 - k. Sign Completion/Exit Agreement.

Section 3. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 4. REPEALING CLAUSE. All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 5. EFFECTIVITY. This Order shall take effect immediately.
