



EXECUTIVE ORDER NO. 1

**“AN ORDER RECONSTITUTING THE PROVINCIAL
IMPLEMENTING TEAM FOR THE RESPONSIBLE
PARENTHOOD AND REPRODUCTIVE HEALTH (RPRH) LAW”**

WHEREAS, Republic Act No. 10354 otherwise known as the Responsible Parenthood and Reproductive Health Act was approved on December 12, 2012. For its effective and efficient implementation, employment of implementing teams at the local level, from provincial to barangay level will serve the purpose of the legislature to address population control as a mechanism for poverty alleviation through the promotion of responsible parenthood and reproductive health;

WHEREAS, the national government has repeatedly declared the intensified implementation of the National Program on Population and Family Planning (NPPFP) as a national policy and priority strategy;

WHEREAS, the Philippine Development Plan (PDP) for 2017-2022 has likewise included the achievement of demographic dividend as a key strategy in harnessing the country's growth potential;

WHEREAS, the implementation of the priority strategies entails the mobilization and full participation of LGUs, particularly in the delivery of the full range of family planning information and services, especially among the marginalized and underserved population;

WHEREAS, there is a need to reconstruct the existing Provincial Implementing Team for Responsible Parenthood and Reproductive Health (RPRH) Law;

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Provincial Implementing Team for the Responsible Parenthood and Reproductive Health (RPRH) Law, to wit:

Section 1. Composition. That the **Provincial RPRH Law Implementing Team** is hereby organized as follows;

Section 2. Duties and Functions. The Provincial RPRH Law Implementing Team shall have the following duties and responsibilities;

1. Conduct regular quarterly meetings and special meetings when necessary;
2. Formulate policies necessary to promote the programs on Population and Family Planning which will cater the basic needs of men and women;
3. Prepare Annual Work and Financial Plan (AWFP);
4. Prepare and submit Semestral Accomplishment Report based on AWFP

Section 3. Repealing Clause. All prior orders, rules, regulations, and issuances or parts thereof, issued by the Province, that are inconsistent with this Order are hereby repealed, amended, or modified accordingly.

Section 4. Effectivity. This Executive Order shall take effect immediately until further revoked or amended by the undersigned.
