CREATION OF THE PROVINCIAL TECHNICAL WORKING GROUP (TWG) FOR THE INTEGRATION OF LOCAL HEALTH SYSTEM IN THE PROVINCE OF OCCIDENTAL MINDORO

WHEREAS, the Province of Occidental Mindoro expressed its intent to implement and demonstrate the health reforms and milestone aimed by Universal Health Care (UHC) Act or Republic Act No. 11223, particularly the integration of local health systems into Province-Wide Health Systems (PWHS);

WHEREAS, as UHC Integration Site, the Province is expected to operationalize and fully implement all local health systems reforms in the UHC Act, particularly those in relation to managerial and financial aspects of the integration of local health systems;

WHEREAS, Chapter V, Section 19 of the UHC Act provides that the Provincial Health Board shall oversee and coordinate the integration of health services for Province-Wide Health System (PWHS) to be composed of municipal health systems;

WHEREAS, to successfully implement the UHC Act in the province, there is a need to formally constitute the composition of a Technical Working Group (TWG) that will assist the Provincial Health Board (PHB) in the managerial, technical, and financial integration of the local health systems in the Province of Occidental Mindoro;

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the **CREATION OF THE PROVINCIAL TECHNICAL WORKING GROUP (TWG) FOR THE INTEGRATION OF LOCAL HEALTH SYSTEM IN THE PROVINCE OF OCCIDENTAL MINDORO**.

Section 1. COMPOSITION. The Technical Working Group (TWG) shall be composed of the following:

Section 2. FUNCTIONS OF TWG. The TWG shall act as an advisory committee to the PHB and undertake necessary activities pursuant to UHC Act, its Implementing Rules and Regulations (IRR), and other related national policies and guidelines, to wit:

1. Advocate for the integration of the local health systems;
2. Convene the key stakeholders in the province to discuss and agree on the need to develop a PWHS as part of ensuring quality, affordable, comprehensive, and efficient health care in the province;
3. Assist in the conduct of preparatory works needed to facilitate the organization of the PWHS, such as mapping of the service capabilities of health facilities and services, including the status of DOH license and PhilHealth accreditation, and catchment populations; drafting of operational guidelines and other technical documents; conduct of baseline assessment, among others;
4. Assist in the managerial, technical, and financial integration of the local health systems, including the monitoring of implementation and functionality of the management support systems such as:
 - a. strategic and investment planning;
 - b. human resources for health management and development system;
 - c. information system, including interoperable electronic medical records system among health providers;
 - d. epidemiology and surveillance system;
 - e. logistics and supply chain management;
 - f. functional two-way referral system;
 - g. disaster risk reduction management for the health system; and
 - h. implementation of proactive and effective health promotion programs or campaigns;
5. Recommend to the PHB the considerations for the equitable distribution of the SHF;
6. Advocate for public-private partnerships to facilitate complementation of efforts;
7. Create technical sub-committees, as deemed necessary; and
8. Perform such other functions and acts as may be necessary, proper, and incidental to the attainment of its objectives.

Section 3. SECRETARIAT. The Provincial Health office (PHO) shall serve as the secretariat of the TWG. They shall perform the following duties and functions:

1. To provide communication, coordination, and liaison support to all activities of the TWG;
2. To perform record management of all documents and such other functions and acts as may be necessary.

Section 4. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 5. REPEALING CLAUSE. All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 6. EFFECTIVITY. This Order shall take effect immediately.
