EXECUTIVE ORDER NO. 10

AN ORDER PLACING ALL GOVERNMENT OFFICES AND BUILDINGS WITHIN THE PROVINCIAL CAPITOL COMPOUND OF MAMBURAO, OCCIDENTAL MINDORO UNDER LOCKDOWN FROM MAY 12, 2021 UNTIL MAY 23, 2021

WHEREAS, National Task Force (NTF) Against COVID-19 issued NTF Memorandum Circular No. 2 Series of 2020 dated June 15, 2020 providing for Operational Guidelines on the Application of the Zoning Containment Strategy in the Localization of the National Action Plan Against COVID-19 Response;

WHEREAS, the Municipality of Mamburao has an increasing number of COVID-19 cases within its area of jurisdiction. The Provincial Government of Occidental Mindoro, in its Capitol Main Building alone, recently tallied a total of ten (10) confirmed cases of COVID-19 among its employees. Said ten (10) employees, in turn, have a total of 119 close contacts and twelve (12) of whom also turned out to be positive for COVID-19. Meanwhile, other close contacts are still awaiting the results of their RT-PCR tests;

WHEREAS, considering the present predicament, the Provincial Inter-Agency Task Force, in its meeting on May 10, 2021, reached a consensus to place all government offices and buildings within the Provincial Capitol Compound of Mamburao, Occidental Mindoro under lockdown, upon concurrence of the Regional Inter-Agency Task Force (RIATF)-MIMAROPA;

WHEREAS, the RIATF-MIMAROPA, in its communication dated May 11, 2021, concurred with the decision of the Provincial Government to impose lockdown in all government buildings and offices within the Provincial Capitol Compound of Mamburao, Occidental Mindoro beginning May 12, 2021 to May 23, 2021;

WHEREAS, in view of the foregoing, there is an urgent need to place all government offices and buildings within the Provincial Capitol Compound of Mamburao, Occidental Mindoro under lockdown from May 12, 2021 until May 23, 2021 to prevent, or at least, mitigate the transmission and spread of COVID-19 infection within the area.

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor, Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. LOCKDOWN OF ALL GOVERNMENT OFFICES AND BUILDINGS WITHIN THE PROVINCIAL CAPITOL COMPOUND.

All government offices and buildings located within the Provincial Capitol Compound of Mamburao, Occidental Mindoro are hereby placed under lockdown from May 12, 2021 until May 23, 2021. As such, said area shall be under Critical Zone (CrZ) or Enhanced Community Quarantine (ECQ) for the said period.

Section 2. ASSISTANCE FROM THE PHILIPPINE NATIONAL POLICE IN PROVIDING MONITORING AND SECURITY IN THE AREA.

During the period of localized lockdown, assistance from the Philippine National Police-Mamburao Municipal Police Station to provide monitoring and security in the Provincial Capitol Compound is hereby enjoined.

Section 3. STRICT COMPLIANCE UNDER PAIN OF SANCTIONS.

This Executive Order shall be strictly implemented by the lawful authorities and complied with by all persons or establishments under pain of administrative and/or criminal sanctions under applicable laws, orders, and issuances.

Section 4. SEPARABILITY CLAUSE.

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 5. REPEALING CLAUSE.

All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 6. EFFECTIVITY.

This ORDER shall take effect from May 12, 2021 to May 23, 2021 or until withdrawn or extended by another issuance.
