**CREATION OF AN EXECUTIVE COMMITTEE THAT SHALL PREPARE AND CRAFT THE
DEVOLUTION TRANSITION PLAN (DTP) FOR THE PROVINCIAL GOVERNMENT OF
OCCIDENTAL MINDORO AND FOR OTHER PURPOSES**

WHEREAS, in *Mandanas, et al. v. Executive Secretary, et al.* (G.R. Nos. 199802 and 208488), the Supreme Court held that all collections of national taxes, except those accruing to special purpose funds and special allotments for the utilization and development of the national wealth, should be included in the computation of the base of the just share of LGUs;

WHEREAS, with the expected substantial increase in the shares of the LGUs from the national taxes, it will empower LGUs in providing basic services and facilities to their constituents, and aid them in the effective discharge of other duties and functions devolved to them under Section 17 of RA No. 7160;

WHEREAS, President Rodrigo R. Duterte issued on June 1, 2021 Executive Order No. 138 entitled "**Full Devolution of Certain Functions of the Executive Branch to Local Governments, Creation of a Committee on Devolution, and For Other Purposes**". Section 5 of EO No. 138 states that "*The national government agencies (NGAs) concerned and all LGUs shall prepare their respective devolution transition plans (DTPs) which conform to the guidelines to be jointly issued by the Department of Budget and Management (DBM) and the Department of the Interior and Local Government (DILG).*"

WHEREAS, section 10 of EO No. 138 also states that "*Consistent with Section 5 of this Order, all LGUs shall likewise prepare their DTPs in close coordination with the NGAs concerned, especially with regard to devolved functions and services critical to them. The DTPs of LGUs shall be used as a guide in the monitoring and performance assessment of the LGUs by the DBM, DILG and NGAs concerned.*"

WHEREAS, in view of the foregoing, there is an imperative need to create an executive committee that shall prepare and craft the Devolution Transition Plan for the Provincial Government of Occidental Mindoro in anticipation of the implementation of the "Mandanas Ruling" in year 2022.

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the **CREATION OF AN EXECUTIVE COMMITTEE THAT SHALL PREPARE AND CRAFT THE DEVOLUTION TRANSITION PLAN (DTP) FOR THE PROVINCIAL GOVERNMENT OF OCCIDENTAL MINDORO**.

Section 1. CREATION. An executive committee that shall prepare and craft the Devolution Transition Plan (DTP) for the Provincial Government of Occidental Mindoro is hereby created. It shall be composed of the following:

Section 2. EXECUTIVE COMMITTEE. The Executive Committee shall be primarily responsible for the preparation and crafting of the Devolution Transition Plan for the Provincial Government of Occidental Mindoro in conformity with the Guidelines to be jointly issued by the Department of Budget and Management (DBM) and the Department of the Interior and Local Government (DILG).

Section 3. DUTIES AND FUNCTIONS OF THE EXECUTIVE COMMITTEE.

- a) Prepare and craft the Devolution Transition Plan (DTP) for the Provincial Government in close coordination with the NGAs concerned, especially with regard to devolved functions and services critical to them;
- b) Formulate the Capacity Development Agenda for the Provincial Government based on the assessment framework and guidelines to be issued by the DILG-Local Government Academy (LGA).
- c) Formulate communication plans and strategies for the Provincial Government which are aligned and complementary to the communications plan formulated and approved by the Committee on Devolution (ComDev).
- d) To perform other duties and functions as may be prescribed by the Provincial Governor as the Chairperson of the Executive Committee.

Section 4. SECRETARIAT. There shall be a Secretariat to be composed of personnel from the Provincial Planning and Development Office. It shall primarily provide administrative and technical support to the Executive Committee.

Section 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 6. REPEALING CLAUSE. All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.
