**EXECUTIVE ORDER NO. 19**  
**Series of 2021**

**"AN ORDER IMPOSING GENERAL COMMUNITY QUARANTINE (GCQ) IN THE PROVINCE OF OCCIDENTAL MINDORO STARTING SEPTEMBER 8, 2021 TO SEPTEMBER 30, 2021"**

**WHEREAS**, President Rodrigo Roa Duterte issued Proclamation No. 1021 Series of 2020 on September 16, 2020 extending the period of State of Calamity throughout the Philippines until September 21, 2021;

**WHEREAS**, the Province of Occidental Mindoro will be placed under General Community Quarantine (GCQ) starting September 8, 2020 to September 30, 2020 by virtue of Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) Resolution No. 136-F Series of 2021;

**WHEREAS**, in view of IATF Resolution No. 136-F Series of 2021, there is an imperative need to adopt the imposition of General Community Quarantine (GCQ) in the entire province of Occidental Mindoro for the above-stated period in order to help mitigate the surge of COVID-19 within our area of jurisdiction.

**NOW, THEREFORE, I, EDUARDO B. GADIANO**, Governor, Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

**Section 1. IMPOSITION OF GENERAL COMMUNITY QUARANTINE IN THE PROVINCE OF OCCIDENTAL MINDORO.**

By virtue of IATF Resolution No. 136-F Series of 2021, the entire Province of Occidental Mindoro is hereby placed under General Community Quarantine beginning September 8, 2021 until September 30, 2021, without prejudice to its reclassification as may be warranted and the declaration of localized Enhanced Community Quarantine in critical areas.

**Section 2. GUIDELINES FOR AREAS UNDER GCQ ARE ADOPTED AND SHALL BE IMPLEMENTED DURING THE PERIOD OF GCQ.**

For the above purpose, guidelines for areas under General Community Quarantine (GCQ) as provided under Section 4 of IATF Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines updated as of August 19, 2021, are hereby adopted and shall be implemented during the period of GCQ in the province. Also, all other Orders, Resolutions and Guidelines issued by the IATF and National Government Agencies relative to General Community Quarantine shall still apply and shall be continuously implemented.

**Section 3. SEPARABILITY CLAUSE.**

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.
