# "CREATING THE COMMITTEES FOR THE CELEBRATION OF THE 71st FOUNDING ANNIVERSARY OF OCCIDENTAL MINDORO - ARAWATAN FESTIVAL 2021, DEFINING THEIR FUNCTIONS AND FOR OTHER PURPOSES"

**WHEREAS,** the Province of Occidental Mindoro will celebrate the Arawatan Festival on its 71<sup>st</sup> Founding Anniversary this November 15, 2021;

**WHEREAS,** it is imperative for the Provincial Government of Occidental Mindoro to ensure the order and success of the entire anniversary such that the constitution of committees to work on the events is necessary;

**NOW THEREFORE, I, EDUARDO B. GADIANO,** Governor of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the creation of the working committees for the celebration of the 71 st Founding Anniversary of the province, defining their functions, and for other purposes;

#### IV. Repealing Clause.

If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

#### V. Separability Clause.

All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

#### VI. Effectivity. This Executive Order shall take effect immediately.
