“AN ORDER AMENDING EXECUTIVE ORDER NO. 54, S. 2022, EXECUTIVE ORDER NO. 18, S. 2022, EXECUTIVE ORDER NO. 41, S. 2022, RECONSTITUTING THE PROVINCIAL PEACE AND ORDER COUNCIL (PPOC) AND ITS SECRETARIAT, SPECIAL ACTION COMMITTEES (SACs) ON ANTI-INSURGENCY, ANTI-CRIMINALITY, AND PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN TECHNICAL WORKING GROUP (TWG) OF OCCIDENTAL MINDORO, DEFINING THEIR DUTIES AND FUNCTIONS AND FOR OTHER PURPOSES”

WHEREAS, Section 116 of Republic Act No. 7160 (RA 7160) otherwise known as the Local Government Code of 1991 provides that “There is hereby established in every province, city and municipality a local peace and order council, pursuant to Executive Order Number Three Hundred Nine (E.O. No. 309), as amended, Series of 1998. The local peace and order councils shall have the same composition and functions as those prescribed by said executive order.”

WHEREAS, On January 5, 2009, the President of the Republic of the Philippines promulgate Executive Order No. 773, further amending Executive Order No. 309;

WHEREAS, as provided under Memorandum Circular No. 2019-143 or the Omnibus Guidelines for Peace and Order Councils (POCs) dated August 27, 2019, it is among the duties and functions of the Provincial Peace and Order Council (PPOC) to create a Special Action Committee (SAC) on Anti-Insurgency and Anti-Criminality, Crisis Management, and other SACs, to prevent or address the issuances or incidents on peace and order and public safety;

WHEREAS, Executive Order No. 54, s. 2022 was issued providing for the re-organization of the PPOC of Occidental Mindoro;

WHEREAS, Executive Order No. 18, s. 2022 was issued providing for the creation of Special Action Committees (SACs) on anti-insurgency, anti-criminality, and public safety under PPOC of Occidental Mindoro;

WHEREAS, Executive Order No. 41, s. 2022 was issued amending the composition of the POPS TWG;

WHEREAS, there is a need to amend the said Executive Orders for the reconstitution of the Provincial Peace and Order Council (PPOC), SACs and POPS of Occidental Mindoro due to tenure of office, re-assignment and election of the previous members of the council, to ensure more comprehensive and efficient coordination of provincial government efforts and active participation of citizens relative to the conduct of provincial campaign against criminality, insurgency and subversion.

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the power vested in me by law, do hereby order and direct the RECONSTITUTION OF THE **PROVINCIAL PEACE AND ORDER COUNCIL (PPOC), SPECIAL ACTION**

Section 5. Roles and Functions of the Provincial Peace and Order Council (PPOC). The Provincial Peace and Order Council shall have the following roles and functions:

- a. Convene the Peace and Order Council quarterly, or as often as the need arises;
- b. Invite other concerned agencies, not included in E.O. 773, s. 2009, (e.g. intelligence communities or agencies) to join or participate in POC meetings and/or activities;
- c. Formulate a 3-year Provincial Peace and Order Council (PPOC) and Public Safety (POPS) Plan, to be incorporated in the Comprehensive Development Plan (CDP);
- d. Provide a forum for inter-disciplinary dialogue and deliberation of major issues and concerns affecting peace, order and public safety nationwide;
- e. Recommend strategic actions or activities aimed at promoting, improving or enhancing peace, order and public safety measures, including ant insurgency measures, within their respective jurisdictions;
- f. Recommend measures to converge and orchestrate internal security operations efforts of civil authorities and agencies, military and police;
- g. Formulate and adopt an effective mechanism for the coordination, cooperation, and consultation involving the local executives, citizenry and law enforcement agencies under R.A. 6975, as amended, in the adoption of the Community and Service-Oriented Policing (CSOP) System;
- h. Apply moral suasion to and/or recommend sanctions against local chief executives who are giving material and political support to the insurgents;
- i. Monitor the provision of livelihood and infrastructure development programs and projects in the remote rural and indigenous population areas to isolate them from the insurgents' ideological, political and organizational works;
- j. Create a Special Action Committee (SAC) to address the immediate issues on peace and order and public safety, in case of emergencies;
- k. Create a Technical Working Group (TWG) for the purpose of POPS Planning, following the guidelines prescribed by the DILG on the tools and processes on POPS Planning;
- l. Submit semestral POC Accomplishment Report to the NPOC, through their respective POC Secretariats;

- m. Serve as the convergence mechanism to support the Comprehensive Local Integration Program (CLIP) Committee in its implementation, at the Provincial and HUG POC level;
- n. Provide staff/s and financial support to POC Secretariat; and
- o. Perform such other functions as may be directed by law, the National Peace and Order Council, Regional Peace and Order Council, or the President.

Section 6. Roles and Functions of the Provincial Peace and Order Council (PPOC) Secretariat. The Roles and functions of the PPOC Secretariat shall be as follows:

- a. Assist the Chairperson in the conduct of the PPOC Meetings;
- b. Provide technical assistance in the performance of administrative and technical tasks of the PPOC;
- c. Recommend and prepare PPOC agenda and other required documents during PPOC meetings;
- d. Prepare resolutions of the Council and the minutes of the meetings;
- e. Prepare and submit semestral PPOC Accomplishment Report to the NPOC, through the PPOC Secretariat;
- f. Prepare and submit quarterly PPOC Secretariat Accomplishment Report to the NPOC, through the PPOC Secretariat;
- g. Monitor provincial peace and order situation and submit a quarterly report to the NPOC, through the PPOC Secretariat;
- h. Monitor the functionality of POCs in the Municipal, and Barangay levels;
- i. Monitor the functionality of the BPOCs and submit annual consolidated Functionality Report;
- j. Provide technical support or assistance to activities related to CLIP, PAMANA, Task Forces, and other programs concerned with peace and order and public safety of the province; and
- k. Perform such other tasks as may be directed by the Council.

Section 7. Duties and Responsibilities of the Special Action Committees (SACs).

A. The Special Action Committees on Anti-Insurgency shall exercise the following functions:

- 1. Identify specific PPPSA or PPSA that will prevent and counter insurgency;
- 2. Identify the point persons or agencies who will take the lead for every anti-insurgency PPPSAs identified;
- 3. Propose cost of implementation, anticipated timeline, and other factors pertaining to the activities;
- 4. Initiate and implement all ELCAC initiatives and all related activities;
- 5. Frame each activity as part of a comprehensive approach;
- 6. Submit identified anti-insurgency and ELCAC activities to the POPS Plan TWG for inclusion in the POPS Plan;
- 7. Implement and monitor the POPS Plan funded PPSAs;
- 8. Closely coordinate with PPOC Secretariat relative to the implementation of identified activities;
- 9. Submit the following reports:
 - a. Semestral accomplishment report, submit not later than 15th day of August for 1st Semester and 15th day of March for the 2nd Semester;
