**AN ORDER AMENDING EXECUTIVE ORDER NO. 11, SERIES OF 2022 ESTABLISHING THE
STATEMENT OF ASSETS, LIABILITIES AND NET WORTH (SALN) REVIEW AND
COMPLIANCE COMMITTEE (RCC) FOR THE PROVINCIAL GOVERNMENT OF OCCIDENTAL
MINDORO AND FOR OTHER PURPOSES**

WHEREAS, Section 17, Article XI of the 1987 Philippine Constitution requires public officers and employees to submit upon assumption of office and during such period as may be required by law, a declaration under oath of their assets, liabilities and net worth (SALN);

WHEREAS, Section 8 of Republic Act No. 6713 (Code of Conduct and Ethical Standards for Public Officials and Employees) requires the declarant *"to accomplish and submit declarations under oath of, and the public has the right to know, their assets, liabilities, net worth and financial and business interests including those of their spouses and of unmarried children under eighteen (18) years of age living in their households;"*

WHEREAS, Section 10 of Republic Act No. 6713 provides that the designated committees of the House of Congress and heads of agencies of the executive and judicial department shall establish procedures for the review of the SALN and determine if the same has been submitted on time, complete and in proper form and render opinion interpreting the provisions on review and compliance procedure in the filing thereof;

WHEREAS, CSC Resolution No. 060231 dated February 1, 2006, amended and clarified Rule VIII of the Rules Implementing Republic Act No. 6713 on the review and compliance of the SALN wherein officials who are authorized to establish review and compliance procedure in the legislative, executive and judicial departments of the government were identified;

WHEREAS, the Civil Service Commission promulgated Resolution No. 1300455 adopting the guidelines in the review and compliance procedure in the filing and submission of the SALN;

WHEREAS, Executive Order No. 11, Series of 2022 was promulgated providing for the creation of the Statement of Assets, Liabilities and Net Worth (SALN) Review and Compliance Committee (RCC) for the Provincial Government of Occidental Mindoro;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by the law, do hereby order:

SECTION 1. COMPOSITION.

The SALN Review and Compliance Committee (RCC) shall be composed of the following members:

SECTION 2. FUNCTIONS.

The Review and Compliance Committee shall be designated and authorized by the head of the agency to perform the following functions:

1. Receive the SALN and to evaluate if the same has been submitted on time, complete and in proper form;

2. Prepare a list of the following employees, in alphabetical order, on or before May 15 of every year:
 - a. Those who filed their SALNs with complete data;
 - b. Those who filed their SALNs but with incomplete data; and
 - c. Those who did not file their SALNs.
3. Issue a Certification that the SALNs have been reviewed to determine whether the SALNs were submitted on time, are complete and are in proper form; and
4. Other functions relative to SALNs as may be required by the head of the agency or in accordance with resolutions promulgated by the Civil Service Commission.

SECTION 3. SEPARABILITY CLAUSE.

If any section or provision of this Order is held unconstitutional or invalid, any other section or provision not affected thereby shall remain valid and effective.

SECTION 4. REPEALING CLAUSE.

All orders, rules and regulations inconsistent with the provisions of this Act are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE.

This Order shall take effect immediately and shall remain in force until expressly revoked.
