EXECUTIVE ORDER NO. 62-A

Series of 2022

AN ORDER CREATING A PROVINCIAL REVIEW TEAM FOR LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLANS (LDRRMPs) OF THE PROVINCE OF OCCIDENTAL MINDORO, AND DEFINING ITS ROLES AND RESPONSIBILITIES IN THE CONDUCT OF LOCAL DRRM PLAN REVIEW

WHEREAS, it is stipulated in Priority 4 (a) of Sendai Framework for Disaster Risk Reduction (SFDRR) 2015-2030 that it is important to prepare or review and periodically update disaster preparedness and contingency policies, plans and programmes with the involvement of the relevant institutions, considering climate change scenarios and their impact on disaster risk, and facilitating, as appropriate, the participation of all sectors and relevant stakeholders;

WHEREAS, Section 2 (e) of RA 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 states that it is the policy of the state to develop, promote, and implement a comprehensive Disaster Risk Reduction and Management Plan (DRRMP) that aims to strengthen the capacity of the national government and the local government units (LGUs), together with partner stakeholders, to build the disaster resilience of communities, and to institutionalize arrangements and measures for reducing disaster risks, including projected climate risks, and enhancing disaster preparedness and response capabilities at all levels;

WHEREAS, it is also the policy of the state to adopt and implement a coherent, comprehensive, integrated, efficient, and responsive disaster risk reduction program incorporated in the development plans at various levels of government;

WHEREAS, National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum Circular No. 13, s. 2018 amended the prescribed guidelines in the conduct of Local Disaster Risk Reduction and Management Plans (LDRRMPs) by expanding the membership of the LDRRMP Review Team;

WHEREAS, this order is being issued to ensure that the Municipal Local DRRM Plans are aligned with Provincial DRRM plan, to guarantee that the DRRM-CCA programs, projects and activities (PPAs) in the Municipal Local DRRM Plans are appropriate to the hazards present in the LGUs, to ensure that the Sanggunian approved Annual Investment Plan (AIP) for DRRM-CCA of concerned LGU is consistent with their LDRRM Plan, and to guarantee the judicious utilization of the Local DRRM Fund.

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the CREATION OF PROVINCIAL REVIEW TEAM FOR LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLANS (LDRRMPs) OF THE PROVINCE OF OCCIDENTAL MINDORO, AND DEFINING ITS ROLES AND RESPONSIBILITIES IN THE CONDUCT OF LOCAL DRRM PLAN REVIEW:

Section 1. CREATION AND COMPOSITION.

The Provincial Review Team for Local Disaster Risk Reduction and Management Plans (LDRRMPs) of the Province of Occidental Mindoro is hereby created. It shall be composed of the following:

Section 2. ROLES AND RESPONSIBILITIES

The Provincial Review Team for Local Disaster Risk Reduction and Management Plans (LDRRMPs) of the Province of Occidental Mindoro shall perform the following roles and responsibilities:

- Conduct a review of the Municipal DRRM Plans pursuant to the prescribed guidelines stated under NDRRMC Memorandum Circular No. 13, s. 2018 and other Review Tool and Checklist that the National DRRM Council prescribes and ensure its alignment with the Provincial DRRM Plan;
- Ensure alignment of Sanggunian-approved Annual Investment Program (AIP) for DRRM-CCA
 of concerned LGU with its Municipal DRRM Plan; and its MDRRMP with the Provincial
 DRRM Plan;
- 3. Evaluate whether the DRRMC-CCA programs, activities and projects (PAPs) in the MDRRMP are appropriate to the identified hazards of the municipality;
- Shall issue certification of review and recommendations address to the Chairperson of the Regional DRRM Council for the issuance of the certificate of the concerned LGUs once the criteria for the LDRRMP review have been complied; and
- 5. Shall record the result of the review and shall furnish a copy to concerned LGUs.

Section 3. FUNDING. The funding requirement of this Provincial Review Team (PRT) shall be sourced out from the calamity fund of the province under the Provincial Disaster Risk Reduction and Management Office (PDRRMO).



Section 4. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 5. REPEALING CLAUSE. All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 6. EFFECTIVITY. This executive order shall take effect immediately.
