



EXECUTIVE ORDER NO. 8
Series of 2021

"PROVIDING FOR THE RECONSTITUTION OF PROVINCIAL PROJECT MONITORING COMMITTEE (PPMC) IN THE PROVINCE OF OCCIDENTAL MINDORO, DEFINING ITS DUTIES AND FUNCTIONS AND FOR OTHER PURPOSES"

WHEREAS, Executive Order No. 376, Series of 1989, as amended by Executive Order No. 93, Series of 1993, provided for the establishment of the Regional Project Monitoring and Evaluation System (RPMES) as an institutional mechanism for monitoring and evaluating projects at the national, regional, national, provincial, and city/municipal levels;

WHEREAS, pursuant to the issuances above-mentioned, the Project Monitoring Committee (PMC) was subsequently mobilized, established by virtue of Memorandum Order No. 175, Series of 1988 to operationalize and implement the RPMES at the provincial, city, and municipal levels;

WHEREAS, DILG Memorandum Circular No. 2004-78, Series of 2004 was subsequently issued to facilitate organization and reconstitution of PMCs nationwide and to further strengthen the roles of said committee in ensuring transparency and accountability in the implementation of local development programs and projects;

WHEREAS, the Provincial Government of Occidental Mindoro issued Executive Order No. 36 Series of 2019 also known as "Providing for the RE-Organization of the Occidental Mindoro's Project Monitoring and Evaluation Systems (OMPMES) and the Project Monitoring Committee (PMC) for this Purpose";

WHEREAS, with the current emphasis on transparency, accountability, and initiative of the national government to strengthen the alignment of development thrusts and priorities across different levels of government, there is a need to ensure functionality of PMCs particularly in coordinating, monitoring, and evaluating project implementation at the sub-regional levels;

WHEREAS, in light of the foregoing policies, DILG Memorandum Circular No. 2019-188 was issued on November 14, 2019, directing LGUs to organize or reconstitute Sub-Regional Project Monitoring Committees (PMCs) in their respective areas of jurisdiction, anchored on Republic Act 7160 or the Local Government Code of 1991 which devolved functions of monitoring and evaluation (M&E) of programs and projects to LGUs;

WHEREAS, in view of the foregoing, there is an imperative need to reconstitute the Project Monitoring Committee in the Province of Occidental Mindoro.

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the **RECONSTITUTION OF THE PROVINCIAL PROJECT MONITORING COMMITTEE (PPMC)** in the Province of Occidental Mindoro and for other purposes.

Section 1. Composition. The Provincial Project Monitoring Committee (PPMC) of Occidental Mindoro shall be composed of the following:

Section 2. Roles and Responsibilities. The PPMC shall exercise the following functions, viz:

1. Provide the list and schedule of all projects to be monitored to NGOs involved in project monitoring;
2. Collect and process reports of implementers and NGO monitors on the status of project implementation for the information of LDC and next higher-level PMC;
3. Determine problems related to the implementation of programs and projects and verify information to be submitted for analysis and action of the LDC;
4. Provide feedback on the remedial actions of the LDC and follow-up implementation;
5. Prepare and disseminate periodic project monitoring report on the status of project implementation to Regional PMC (RPMC); and
6. Elevate to higher level bodies, e.g. National PMC and RPMC, issued and problems which are not resolved at the LMPC level.

Section 3. Secretariat. The Office of the Provincial Planning and Development Coordinator concerned shall serve as secretariat to the PPMC.

The **Secretariat of the PPMC** shall exercise the following functions, viz:

1. Prepare the M&E work program to be undertaken by the PMC during any given fiscal year which will include the list of the projects and schedule of implementation based on submission of implementing agencies;
2. Provide the Local Chief Executive with information on the projects to be monitored by the PMC; and
3. Facilitate inter-agency, inter-governmental, and field headquarters coordination, if necessary.

Section 4. Separability Clause. If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 5. Repealing Clause. All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 6. Effectivity. This Order shall take effect immediately.
