AN ORDER INSTITUTIONALIZING/CREATING THE RAPID DAMAGE ASSESSMENT AND NEEDS ANALYSIS (RDANA) TEAMS OF THE PROVINCIAL GOVERNMENT OF OCCIDENTAL MINDORO AND PROVIDING FOR ITS COMPOSITION AND FUNCTIONS

WHEREAS, Occidental Mindoro is often visited by typhoons and other hazards due to its geographical location and climatic condition, which led to damage to properties, livelihood, housing, infrastructure and other critical facilities;

WHEREAS, one of the major gaps of this province in terms of response capabilities is the timely and systematic damage assessment reporting to various regional and national agencies;

WHEREAS, according to Rule 7, Section 3 (G) of the Implementing Rules and Regulations of RA 10121, the Office of the Civil Defense shall formulate standard operating procedures for the deployment of Rapid Damage Assessment and Needs Analysis teams, information sharing among different government agencies, and coordination before, during and after disasters at all levels;

WHEREAS, to facilitate the timely submission of damage assessment and needs analysis to various Regional and National response agencies, it is vital for the Provincial Disaster Risk Reduction and Management Council to develop and create a Provincial level RDANA Teams who will be deployed in affected areas after the impact of disasters and or emergency within the province;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the **INSTITUTIONALIZATION/CREATION OF THE PROVINCIAL RAPID DAMAGE ASSESSMENT AND NEEDS ANALYSIS (RDANA) TEAMS AND THE PROVISION OF ITS COMPOSITION AND FUNCTIONS.**

Section 1. COMPOSITION. The Provincial RDANA teams shall be composed of trained RDANA representatives from different provincial government offices and national government, but not limited to, the following:

Above-mentioned composition of teams shall be subject for the approval of EOC manager or the Provincial DRRM Officer prior to deployment.

Section 2. ROLES AND RESPONSIBILITIES.

1. Conduct initial assessment of the situation on the ground and maintain close coordination with the M/BLGUs;
2. Provide quick snapshot of the disaster situation;
3. Conduct data collection as basis for the actual damage assessment;
4. Consolidate the data collected into one (1) RDANA report,

5. Determine the type and extent of damages brought by disaster, including its second threats, the critical needs of the affected population, and the response capacities of the affected localities.
6. Continue to process the re-assessment of needs with response and recovery interventions.

Section 3. ACTIVATION. Activation of RDANA teams shall be based on the alert levels from the Office of the Civil Defense or per request by the Local Chief Executive and massive needs of the community is needed.

Section 4. FUNDING. Mobilization of teams and other expenses relative to the implementation of Rapid Damage Assessment and Needs Analysis (RDANA) shall be charged against the calamity fund of the PGOM under the PDRRMO.

Section 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

Section 6. REPEALING CLAUSE. All Executive Orders, Rule Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 7. EFFECTIVITY. This executive order shall take effect immediately.
