



**EXECUTIVE ORDER NO. 3-A**

**AMENDMENT TO EXECUTIVE ORDER NO. 3 SERIES OF 2019 TO THE EFFECT OF CHANGING THE COMPOSITION OF THE MEMBERS OF PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT COUNCIL (PDRPMC) IN THE PROVINCE OF OCCIDENTAL MINDORO**

**WHEREAS**, Republic Act No. 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 particularly Section 12 thereof mandates the province to create its local disaster risk reduction office that shall be responsible for setting the direction, development, implementation and coordination of disaster risk management programs within its territorial jurisdiction;

**WHEREAS**, in CY 2011 and in compliance with the provisions of RA 10121, the Provincial Government of Occidental Mindoro created the PDRRM Office initially with the following personnel complements, the Provincial Disaster Risk Reduction Management Officer (PDRRMO) and four (4) coordinators for Administration and Training, Operations and Warning, Research and Planning and Emergency and Medical Coordinator;

**WHEREAS**, on August 7, 2019, the Provincial Government of Occidental Mindoro issued Executive Order No. 3 Series of 2019 entitled "Providing for the Organization of the Provincial Disaster Risk Reduction Management Council (PDRPMC) in the Province of Occidental Mindoro";

**WHEREAS**, there is a need to promulgate this Executive Order to amend the composition of the members of the PDRPMC due to retirement, transfer and security of tenure of some members.

**NOW, THEREFORE, I, EDUARDO B. GADIANO**, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. Creation of the Council.** This Order hereby creates the Provincial Disaster Risk Reduction and Management Council (PDRPMC) for the Province of Occidental Mindoro;

**SECTION 2.** Section 2 of Executive Order No. 3 Series of 2019 is hereby amended to read, as follows:

**"SECTION 2. Organization and Composition.** The PDRPMC as herein created shall be composed of the following:

### **SECTION 3. Functions and Responsibilities.**

1. Approve, monitor and evaluate the implementation of the Provincial Disaster Risk Management Plan and annually review, test and develop the plan consistent with other national and provincial planning programs.
2. Ensure the integration of Disaster Risk Reduction and Climate Change Adaptation into the provincial development plans and programs and budget as a strategy in sustainable development and poverty reduction;
3. Recommend the implementation of forced or pre-emptive evaluation of provincial residents if possible.
4. To perform tasks as may be called for by the Provincial governor in the event of calamities or disasters.

**SECTION 4. Secretariat and PDRRMO.** There shall be a Secretariat and Staff to the PDRRMO headed by the Provincial Disaster Risk Reduction and Management Officer to perform the following functions, duties and responsibilities.

1. Provides technical support to the PDRRMO in the formulation, initiation and the implementation of its plans and programs for consideration by the council;
2. To provide secretariat support during regular meeting of the PDRRMO, schedules and calls emergency meetings, conferences and does regular coordination with the MDRRMO in the province.
3. To render reports to the PDRRMO relative to the proposed activities of the MDRRMO, propose consolidated or integrated approach to implement Disaster Plans Programs after approval by the proper authorities concerned.
4. To establish direct linkages between barangay, municipal, national agencies, non-government sectors and offices directly or indirectly responsible for disaster and risk reduction operations in the province.

5. To formulate the policies and guidelines to the Governor thru the PDRRMO that would govern risk reduction operation and related activities in the province.
6. To present to the Provincial Governor thru the PDRRMO, the projects that are prioritized for implementation taking into consideration the resources and capacity of the implementing agency/ies involved.
7. To formulate and present proposals out of the consolidated proposals submitted by the municipalities for all risk reduction and disaster rehabilitation management programs;
8. Prepares and conducts continuous training modules for emergency rescue operations.
9. To perform other duties, functions and responsibilities as may be called for by the Governor for all risk reduction related activities in Occidental Mindoro.

**SECTION 5. Administrative Support**—Whenever needed or requested, all concerned agencies in the provincial government through heads of departments are hereby enjoined to provide technical and administrative support in the implementation of this order.

**SECTION 6. Funding** – Funding as may be required for the implementation of this Order shall be properly charged against the funds appropriate to the Provincial Disaster Risk Reduction Management Office sourced from the budgetary allocation for the year. Non-Government Sector may provide voluntary funding assistance for projects in support to the Disaster Risk Reduction and Management program of the province.

**SECTION 7. Separability Clause** - If any provision of this Executive Order is declared invalid for any reason, the parts not affected thereby shall remain valid and in full force and effect.

**SECTION 8. Repealing Clause** - All Executive Orders, Rules and Regulations issued by this province which are inconsistent with any of the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

**SECTION 9. Effectivity** – This Order shall take effect immediately.
