## **EXECUTIVE ORDER NO. 8**

Series of 2019

## "PROVIDING FOR THE CREATION OF PROVINCIAL ECOLOGICAL SOLID WASTE MANAGEMENT BOARD (PESWMB) OF THE OCCIDENTAL MINDORO, DEFINING ITS DUTIES AND FUNCTIONS AND FOR OTHER PURPOSES"

WHEREAS, it is a declared policy of the State to adopt a systematic and comprehensive solid waste management program which, amongst others, shall ensure the protection of public health and the environment;

WHEREAS, Republic Act 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000" was enacted by the 11<sup>th</sup> Congress of the Philippines for the purpose;

WHEREAS, pursuant to the relevant provision of Republic Act No. 7160, otherwise known as the "Local Government Code", the Local Government Unit shall be primarily responsible for the implementation and enforcement of the provisions of the Ecological Solid Waste Management Act of 2000;

**WHEREAS,** in compliance with the provisions of the aforementioned laws, a Provincial Ecological Solid Waste Management Board shall be established in every province, to be chaired by the Governor;

**NOW THEREFORE, I, EDUARDO B. GADIANO,** Governor of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the following:

Section I. Establishment of the Provincial Ecological Solid Waste Management Board of the Province of Occidental Mindoro purposely for the implementation and enforcement of the provisions of Republic Act 9003.

**Section II.** The composition of the Provincial Ecological Solid Waste Management Board shall be the following in consonance with Republic Act 9003:

## REPRESENTATIVE FROM EACH GOV'T AGENCY PROCESSING RELEVANT TECHNICAL AND MARKETING EXPERTISE, AS MAY BE DETERMINED BY THE BOARD

**Section III.** The Provincial Ecological Solid Waste Management Board shall have the following Functions and Responsibilities:

- 1. Develop a provincial ecological solid waste management plan from the submitted solid waste management plans of the respective eleven (11) Municipal Solid Waste Management Boards. It shall review and integrate the submitted plans of the respective Planning and Development Office, perform overall coordination of CBMS implementation activities in the province and provide management support to the PTWG and spearhead in the creation of municipal TWG;
- 2. Provide the necessary assistance in providing technical support in data generation and analysis particularly in agriculture-related indicators;
- 3. Recommend measures and safeguards against pollution and for the preservation of the national ecosystem;
- 4. The Provincial Social Welfare and Development Office shall assist in providing technical support in data and analysis particularly for CBMs core indicators;
- 5. The Provincial Budget Office shall assist in identifying funding source for the CBMs implementation activities;
- 6. Coordinate the efforts of the component municipalities in the implementation of the Provincial Ecological Solid Waste Management Plan;
- 7. Develop an appropriate incentive scheme as an integral component of the Provincial Ecological Solid Waste Management Plan;
- 8. Convene joint meeting of the Provincial and Municipal Solid Waste Management Boards at least every quarter for purpose of integrating, synchronizing, monitoring and evaluating the development and implementation of its provincial solid waste management plan;
- 9. Represent any of its component municipality in coordinating its resource in operational requirements with agencies of the national government;
  - 10. Oversee the implementation of the Provincial Solid Waste Management Plan;
- 11. Review every two (2) years or as the need arises, the Provincial Ecological Solid Waste Management Plan for purposes of ensuring its sustainability, effectiveness and relevance in relation to local and international development in the field of solid waste management; and
- 12. Allow for the clustering of LGUs for the solution of common solid waste management problems.

Section IV. Effectivity. This Executive Order shall take effect immediately.
